Project Title: Madera Quarry (California Endangered Species Act Incidental Take Permit No. 2081-2012-005-04 (ITP) Major Amendment No. 1)

Project Location: The project is located in an unincorporated area of Madera County, east of Road 209 approximately 4 miles north of its intersection with State Route 41.

Project Description: This proposed project includes development of a new 78-acre hardrock quarry that will mine 900,000 tons of aggregate annually for 40 years. The project will also include the alignment and widening of Road 209 and improvements to the Road 209/State Highway 41 intersection, as well as the permanent preservation and management of Habitat Management lands to offset the Project related impacts.

The Project will result in impacts to 135.7 acres of California tiger salamander (CTS; *Ambystoma californiense*) habitat including temporary impacts to 14.6 acres associated with the right-of-way improvements, and the permanent loss of 121 acres of CTS habitat. Additional impacts within the 135.7-acre Project Area include 0.90 acres of habitat disturbance occurring in the absence of implementing take minimization measures. Specifically, 0.17 acres of upland habitat subject to ground disturbance in the absence of pre-construction surveys and burrow excavation and 0.73 acres of impacts to upland habitat and drainages to remedy uncontrolled erosion. The project is expected to result in incidental take of CTS, which is designated as a threatened species under the California Endangered Species Act. The ITP referenced above as issued by CDFW authorizes incidental take of species listed under CESA that may occur as a result of Project implementation.

Work on the Project under the ITP has begun and the Major Amendment No. 1 (Amendment) includes changes to the ITP as originally issued. These changes include: (1) updates to the ITP's Contact Person to include an additional point of contact; (2) documentation of impacts to upland habitat and drainages occurring in the absence of implementing take minimization measures required in the ITP, as originally issued; (3) addition of measures to more effectively prevent future erosion of soil stockpiles into Waters of the State; (4) description of additional Habitat Management (HM) lands acreage, funding, and security required to offset impacts to upland habitat and Waters of the State; (5) addition of 52 months to satisfy the compensatory mitigation requirement; and (6) updates to the ITP's Notices section to include current CDFW regional contact information.
