The proposed project is a 450-foot long, right turn lane plus 120-foot bay taper within Caltrans' eastbound State Route 156 right-of-way to accommodate vehicle deceleration and right turns onto southbound The Alameda. A Class II bike lane and a four-foot-wide paved shoulder are included. The new improvements will replace an existing 8-foot shoulder with a 6-foot bike lane, 12-foot right turn lane and 4-foot shoulder for a net new widening of 14 feet.
