Subject: ***Applicability of Transit Priority Area (TPA) to the 670 Mesquit Project*** ref: 2847

The proposed mixed-use development project at 670 Mesquit Street (Project) is located on approximately 5.45 acres on both sides of Mesquit Street north of 7th Street (Project Site) in the Arts District of the City of Los Angeles.

As part of the environmental review process for the Project, the City prepared and circulated an Initial Study, together with a Notice of Preparation for an Environmental Impact Report, on April 25, 2017. Based on information available at that time, page A-3 of Attachment A, *Project Description*, of the Initial Study indicated that the Project Site was not (at that time) identified as being in a transit priority area (TPA). The purpose of this memorandum is to assess based on current information whether the Project is located within a TPA.

Senate Bill (SB) 743 (Public Resources Code Section 21099(d)) established new rules for evaluating certain types of projects' aesthetic and parking impacts under the California Environmental Quality Act (CEQA). PRC Section 21099(d) states: "Aesthetic and parking impacts of a residential, mixed-use residential, or employment center project on an infill site within a transit priority area (TPA) shall not be considered significant impacts on the environment."

PRC Section 21099(a) defines a "transit priority area" as "an area within one-half mile of a major transit stop that is existing or planned, if the planned stop is scheduled to be completed within the planning horizon included in a Transportation Improvement Program adopted pursuant to Section 450.216 or 450.322 of Title 23 of the Code of Federal Regulations." PRC Section 21064.3 defines "major transit stop" as "a site containing an existing rail transit station, a ferry terminal served by either a bus or rail transit service, or the intersection of two or more major bus routes with a frequency of service interval of 15 minutes or less during the morning and afternoon peak commute periods." PRC Section 21099(a) defines an "employment center project" as "a project located on property zoned for commercial uses with a floor area ratio of no less than 0.75 and that is located within a transit priority area." PRC Section 21099(a) defines an "infill site" as "a lot located within an urban area that has been previously developed, or on a vacant site where at least 75 percent of the perimeter of the site adjoins, or is separated only by an improved public right-of-way from, parcels that are developed with qualified urban uses." PRC Section 21555 states that "[a] project shall be considered to be within one-half mile of a major transit stop or high-quality transit corridor if all parcels within the project have no



more than 25 percent of their area farther than one-half mile from the stop or corridor and if not more than 10 percent of the residential units or 100 units, whichever is less, in the project are farther than one-half mile from the stop or corridor."

This state law supersedes the aesthetic impact thresholds in the 2006 L.A. CEQA Thresholds Guide, including those established for aesthetics, obstruction of views, shading, and nighttime illumination. The related City of Los Angeles Department of City Planning (DCP) Zoning Information (ZI) File No. 2452 provides further instruction concerning the definition of transit priority projects and states "[v]isual resources, aesthetic character, shade and shadow, light and glare, and scenic vistas or any other aesthetic impact as defined in the [L.A. CEQA Thresholds Guide] shall not be considered an impact for infill projects within TPAs pursuant to CEQA."

METHODOLOGY FOR DETERMINING MAJOR TRANSIT STOPS

The minimum requirement for falling within a TPA is that a project site be located near the intersection of two bus lines, defined as the midpoint of the intersection where the bus routes meet or cross and where passengers can transfer between them on foot. In particular, all parcels within the project must have no more than 25 percent of their area farther than one-half mile from the stop or corridor and not more than 10 percent of the residential units or 100 units, whichever is less, in the project farther than one-half mile from the stop or corridor.

Eligible bus routes must have headways of 15 minutes or less during morning and afternoon peak periods in both directions. To determine if a bus route is eligible, the total peak hour time is divided by the total number of trips within peak hours. The resulting value must be less than 15 for the bus route to be considered eligible. A bus trip is included in the total number of trips if the median time of the bus's trip falls within the morning or afternoon peak periods.

Metro Local bus routes 18, 60, and 62 run close to the Project Site. Eastbound/southbound buses stop on the corner of 7th Street & Santa Fe Avenue and westbound/northbound buses stop on the corner of 7th Street & Imperial Street. **Figure 1** uses the City's ZIMAS web-mapping feature and demonstrates that the Project Site is within 750 feet of the intersection midpoint. A description of each bus route follows.

- Metro Line 18 – Line 18 is an east/west line that runs from Wilshire Center to Montebello. In the vicinity of the proposed Project, the line runs on 7th Street. Using the methodology in the TOC Guidelines for determining Major Transit Stops, the line has 6.4-minute headways in the morning peak period and 6.0-minute headways in the afternoon peak period in the eastbound direction. The line has 6.0-minute headways in the morning peak period and 6.5-minute headways in the afternoon peak period in the westbound direction.
- Metro Line 60 – Line 60 is a north/south line that runs from Compton to Downtown Los Angeles. Near the Project Site, the line runs on Santa Fe Avenue south of 7th Street and on 7th Street west of Santa Fe Avenue. Applying the methodology in the TOC Guidelines, the line has 6.7-minute headways in the morning peak period and 5.6-minute headways in the afternoon peak period in the northbound direction. The line has 6.2-minute headways in the morning peak period and 6-minute headways in the afternoon peak period in the southbound direction.




- Metro Line 62 – Line 62 is a northwest/southeast line that runs from Hawaiian Gardens to Downtown Los Angeles. Applying the methodology in the TOC Guidelines, the line has 60-minute headways in the morning peak period and 24-minute headways in the afternoon peak period in the northbound/westbound direction. The line has 30-minute headways in the morning peak period and 40-minute headways in the afternoon peak period in the southbound/eastbound direction.

Attachment A provides the annotated schedules, routes, and details on transfer opportunities for Metro Lines 18, 60, and 62 effective June 27, 2021. As shown on **Figure A1**, which illustrates bus transfer opportunities, Metro Lines 18, 60, and 62 share the same bus stop for the eastbound/southbound direction and westbound/northbound direction. The two bus stops are in close proximity (450 feet apart) and located near a signal to facilitate convenient transfers. According to PRC Section 21064.3, Metro Line 62 is not an eligible bus route because one or more of its headways are longer than 15 minutes in peak periods. Metro Lines 18 and 60 are eligible bus lines because all headways are less than 15 minutes in each direction during the morning and the afternoon peak periods. Therefore, the intersection of 7th Street & Santa Fe Avenue meets the definition of a Major Transit Stop. As the intersection of 7th Street & Santa Fe Avenue is within one-half mile of the Project Site, the Project is in a TPA.

CONCLUSION

The 670 Mesquit Project is located within one-half mile of a Major Transit Stop. Therefore, the Project Site is within a TPA.








