


Figure A1-1: Proposed Project Location




Figure A3.2-15: Key View 8 (Altamont Overpass) – Existing




Figure A3.3-1: Important Farmlands (1 of 2)




Figure A3.3-2: Important Farmlands (2 of 2)




Figure A3.3-3: Williamson Act Parcels (1 of 2)




Figure A3.3-4: Williamson Act Parcels (2 of 2)




Figure A3.7-1: Environmental Justice Communities




Figure A3.8-1: Major Regional and Local Faults and Landslide Hazard Zones




Figure A3.8-2: Alquist-Priolo Zones




Figure A3.8-3: Soils (1 of 2)




Figure A3.8-4: Soils (2 of 2)




Figure A3.11-1: FEMA Mapped Flood Zones




Figure A3.11-2: Dam Inundation Boundaries




Figure A3.11-3: Groundwater Basins




Figure A3.12-1: Land Use (1 of 2)




Figure A3.12-2: Land Use (2 of 2)
