

**NOTICE OF INTENT TO ADOPT A
MITIGATED NEGATIVE DECLARATION 2019049126**

**LITTLE TUJUNGA CANYON ROAD OVER BUCK CANYON BRIDGE
REPLACEMENT**

Public Works proposes to replace the existing Little Tujunga Canyon Road over Buck Canyon Bridge to meet current bridge design standards and improve safety and operations in the project area. The project site is located in the San Gabriel Mountains of the Angeles National Forest, in an unincorporated portion of central Los Angeles County, approximately four miles north of the Foothill Freeway (Interstate 210), 4.7 miles northeast of the Pacoima neighborhood in the City of Los Angeles, and three miles east of the community of Sylmar (see attached maps).

The project would replace the existing timber bridge with a new single-span precast, prestressed concrete I-girder structure supported by abutments on deep pile foundation. New wingwalls would be constructed. Concrete barriers with tubular handrails would be installed on both sides of the bridge. The project would also include the reconstruction of approximately 235 feet of roadway on the northside of the bridge and 150 feet on the southside of the bridge. Metal beam guardrails would be installed at the approach corners.

Public Works prepared an Initial Study (IS) and Mitigated Negative Declaration (MND) to assess the impact of the project to the environment and the community. Significant environmental impacts can be addressed through mitigation. The draft IS/MND are being circulated for a 30-day public review, starting April 22, 2019, and ending May 21, 2019. 
