The California Department of Transportation proposes to replace joint seals, placing methacrylate seals, polyester concrete overlays, and spall repairs at various locations in Kern County. Existing thermoplastic striping would be removed, and AC cold planed from bridge decks prior to treating them with methacrylate and polyester concrete overlay. New joint seals would be installed where required. New thermoplastic striping would be replaced in kind. At the Airport Drive onramp separation, the concrete footing at Bent 2 would be repaired. No new right of way would be required. A complete list of locations is attached.
