The project is a General Plan Map Amendment and a Zone Reclassification. The applicant proposes to amend the General Plan designation from C/C (Community Commercial) to R/M (Medium Density Residential) and the zoning designation from C-C (Community Commercial) to R-M (Medium Density Residential), with future plans to construct a maximum of four (4) residences. The project site consists of two (2) vacant lots totaling 13,939 square feet (0.32 acres). The project site is served by the Mokelumne Acres Maintenance District for water and storm drainage and by the Woodbridge Sanitary District for sewer.
