## STANISLAUS COUNTY NOTICE OF PUBLIC HEARING FOR GENERAL PLAN AMENDMENT AND REZONE APPLICATION NO. PLN2019-0077- DERREL'S MINI STORAGE

NOTICE IS HEREBY GIVEN that on April 28, 2020, at 9:00 a.m., or as soon thereafter as the matter may be heard, the Stanislaus County Board of Supervisors will meet in the Basement Chambers, 1010 10th St., Modesto, CA, to consider the Planning Commission's recommendation of approval for General Plan Amendment and Rezone Application No. PLN2019-0077 — Derrel's Mini Storage — Request to amend the General Plan and zoning designation of a 9.77 acre parcel from Agriculture and A-2-40 to Planned Development (P-D) and amend the zoning designation of 3 parcels totaling 3 acres from expired P-D (202) to a new P-D to allow expansion of an existing mini storage and RV storage business in phases. The project site is located at 5024, 5038, and 5118 Tunson Road, and 907 Kiernan Avenue, on the north side of Kiernan Avenue, in the Modesto area. APNs: 004-057-001, 004-057-003, 004-057-004, and 004-057-005. The Board of Supervisors will also consider approval of a CEQA Negative Declaration.
