Project Title: Yuba City Boat Ramp Sediment Removal Project (California Endangered Species Act Incidental Take Permit No. 2081-2020-057-02-A1 (ITP)).

Project Location: The Yuba City Boat Ramp Sediment Removal Project (Project) is located at the confluence of the Feather and Yuba Rivers in the cities of Yuba City and Marysville, in Sutter and Yuba Counties, respectively. The approximate center of the Project is located at latitude 39.1307°, longitude -121.598673°.

Project Description: The amended ITP (Amendment No. 1) amends the original ITP executed on June 1, 2021, to renew the original ITP with an expiration date of June 1, 2031, and provides administrative changes to the project description.

The Amended Project will result in temporary impacts to 14.40 acres of Central Valley spring-run Chinook salmon (*Oncorhynchus tshawytscha*) habitat. The project is expected to result in incidental take of Central Valley spring-run Chinook salmon (*Oncorhynchus tshawytscha*), which are designated as a threatened species under the California Endangered Species Act. The ITP referenced above as issued by CDFW authorizes incidental take of species listed under CESA that may occur as a result of Project implementation.

This is to advise that CDFW, acting as a responsible agency, executed the above-described amendment on the date signed below and made the following determinations regarding the above-described project:
