**DESCRIPTION OF PROJECT:** Gustafson Farms, LLC. is seeking a Minor Use Permit from the County of Lake for a proposed commercial cannabis cultivation operation at 12206 Spruce Grove Road in Lower Lake, California, known as APN 012-060-08 (project parcel). The project will compose of a total of 6,000 ft<sup>2</sup> canopy area and A-Type 13 Distributor Transport Only, Self-Distribution. The applicant will construct three (3) 2,500 ft<sup>2</sup> prefabricated greenhouses/structures and a 120 ft<sup>2</sup> storage that will be used on the 20.1-acre agriculture- and rural land- zoned project property. Current and past land uses of the project property is rural residential. The proposed cultivation area is fairly flat with range been 0-10% and approximately 30% average cross slope of the whole parcel due to the steep hillslope surrounding the project site. The project property is currently improved with a groundwater well, agriculture building, and a single-family house. The proposed canopy areas will be located within greenhouse structures encircled with 6-foot tall chain-link fences; three (3) proposed greenhouse structures will each contain approximately 2,200 ft<sup>2</sup> of canopy (5,000 ft<sup>2</sup> total), and the remaining 1,000 ft<sup>2</sup> canopy area will be located within an existing 2,400 ft<sup>2</sup> agriculture building.

The project would consist of new construction of small structures used within the cultivation area including the construction of (3) 2,500 ft<sup>2</sup> greenhouses, and a 120 ft<sup>2</sup> fertilizer and pesticide

storage. Under section 21080 ministerial project, the permitted use for the Lake County Zoning Ordinance to allow greenhouses (10,000 ft<sup>2</sup> maximum) and accessory structures are permitted use by right within the agriculture- and rural land- zone permitted in Lake County Zoning Ordinance Article 5 and Article 7, respectively.




Figure 1. vicinity map

### NOTICE

Each project applicant shall remit to the county clerk the environmental filing fee before or at the time of filing a Notice of Determination (Pub. Resources Code, § 21152; Fish & G. Code, § 711.4, subdivision (d); Cal. Code Regs., tit. 14, § 753.5). Without the appropriate fee, statutory or categorical exemption, or a valid No Effect Determination issued by the California Department of Fish and Wildlife (CDFW), the Notice of Determination is not operative, vested, or final, and shall not be accepted by the county clerk.

#### COUNTY DOCUMENTARY HANDLING FEE

The county clerk may charge a documentary handling fee of fifty dollars (\$50) per filing in addition to the environmental filing fee (Fish & G. Code, § 711.4, subd. (e); Cal. Code Regs., tit. 14, § 753.5, subd. (g)(1)). A county board of supervisors shall have the authority to increase or decrease the fee or charge, that is otherwise authorized to be levied by another provision of law, in the amount reasonably necessary to recover the cost of providing any product or service or the cost of enforcing any regulation for which the fee or charge is levied (Gov. Code, § 54985, subd. (a)).
