The Downtown San Bernardino Specific Plan envisions the area to be the go-to urban center of the Inland Empire for working, living, socializing, shopping, dining, entertainment, and cultural pastimes. Much of the area is already developed so the Specific Plan includes reuse of existing buildings as well as demolition and replacement of buildings to meet the intent of the Specific Plan. The proposed land use districts would be the new land use and zoning designations for the Specific Plan Area: North Residential; Freeway Commercial; North Gateway; Transit Neighborhood; Downtown Core; County Center; County Mixed-Use Campus; Rail Adjacent; Transit Center. The proposed project would result in a net addition of 14,194 residential units and 11,780,515 square feet of non-residential uses.


