Project Description: The applicant is proposing to divide previously approved Conditional Use Permit No. 22-05 (Westlands Cherry Solar Project) into two (2) new and separate Conditional Use Permits (CUPs). CUP No. 22-05 (Westlands Cherry Solar Project) was previously approved by the Kings County Planning Commission on November 7, 2022, and later amended on August 5, 2024, for a 250 megawatt (MW) commercial solar photovoltaic facility with 250 MW (1,000 megawatt hours [MWh]) of battery storage on 2,079.1 acres to be located at 24924 Nevada Ave., Stratford, APNs 026-300-034, 026-320-006, -010, -011, -017, -020, -021, -022, -023, -024, and 026-330-037. The applicant is proposing that CUP No. 22-05 be superseded by two (2) new CUPs to memorialize a division of responsibilities: 1) CUP No. 26-01: the Cherry BESS Project (40 MW battery storage) and 2) CUP No. 26-02: the Westlands VI Solar Project (250 MW solar facility and 210 MW battery storage). This CUP No. 26-02 (Westlands VI Solar Project) proposes 250 MW commercial solar photovoltaic facility with 210 MW (840 MWh) of battery storage, substation, Operations & Maintenance (O & M) facility, storage building, and ancillary equipment to occupy 2,077.26 acres of the previously approved project footprint, to be located at 24900 Nevada Ave., Stratford, APNs 026-300-034, 026-320-006, -010, -011, -017, -020, -021, -022, -023, -024, & 026-330-037.

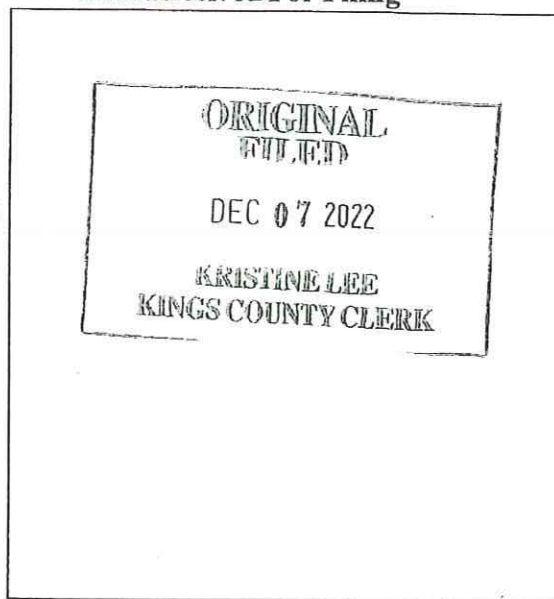

Project Description: The applicant (Westlands Cherry Solar) is proposing to establish a 250-megawatt (MW) solar photovoltaic facility located at 26620 Nevada Avenue, approximately 2.5 miles west of SR-41, Kettleman City, Assessor's Parcel Numbers 026-300-034, 026-320-006, -017, and -020. The project proposes to include an electrical substation, a battery storage facility, and an Operations and Maintenance (O&M) facility. The solar generation from the project will be transferred to a new 230 kilovolt (kV) Nevada-Jayne gen-tie line which will transmit the power south along the 25th Avenue alignment and then west along Nevada-Jayne Avenues to the PG&E Gates Substation approximately 12 miles to the west. The on-site battery storage will include 250 battery containers with 4 MW hours storage capacity each, providing a total energy storage capacity of up to 1,000 MW hours.
