NOTICE OF AVAILABILITY/PUBLIC MEETING OF A DRAFT ENVIRONMENTAL IMPACT REPORT

Pursuant to California Code of Regulations, title 14, section 15087, this is to advise that the California State Lands Commission (Commission), as lead agency under the California Environmental Quality Act (CEQA), has completed a Draft Environmental Impact Report (DEIR) for the proposed Project described below.

Project Title: Rincon Phase 2 Decommissioning Project (Project)

Project Description: The proposed Project would include removal of Rincon Island's remaining surface structures and remediation of the Island's contaminated soil and interstitial water; improvements to the State Coastal Conservancy Parcel adjacent to the Rincon Island Causeway landing/abutment; decommissioning of onshore pipeline connections from the causeway abutment to the vault box; and remediation of the Onshore Facility.

Project Location: Rincon Island is located approximately 3,000 feet offshore of Punta Gorda in Ventura County. The State Coastal Conservancy Parcel is located just east of the Rincon Island Causeway landing, and the 6.01-acre Onshore Facility is located 1.3 miles to the east of Rincon Island, between U.S. Highway 101 and the Pacific Coast Highway.
