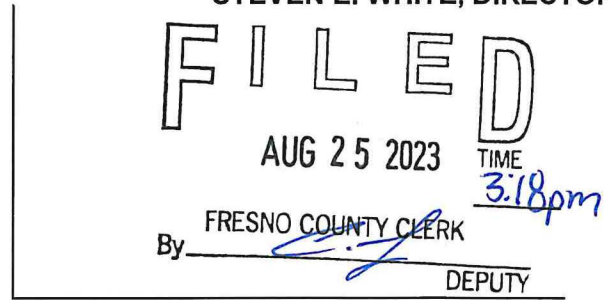

NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

Notice is hereby given that the County of Fresno has prepared Initial Study Application (IS) No. 8404 pursuant to the requirements of the California Environmental Quality Act for the following proposed project:

INITIAL STUDY APPLICATION NO. 8404 and **UNCLASSIFIED CONDITIONAL USE PERMIT NO. 3765** filed by **LEESA GENDEL** proposing to allow the installation of a new freestanding 100' tall monopole style co-locatable wireless telecommunications facility on a 76.68-acre parcel within the RR (Rural Residential, two-acre minimum parcel size) Zone District. The subject parcel is located on the southeast corner of W. Shaw Ave. and Grantland Ave., westerly adjacent to the City of Fresno (APN: 512-031-01S), (Section 16, Township 13s, Range 19e) (Sup. Dist. 1).

(hereafter, the "Proposed Project")

The County of Fresno has determined that it is appropriate to adopt a Mitigated Negative Declaration for the Proposed Project. The purpose of this Notice is to (1) provide notice of the availability of IS Application No. 8404 and the draft Mitigated Negative Declaration and request written comments thereon; and (2) provide notice of the public hearing regarding the Proposed Project.
