The Project includes the demolition and removal of 4.8 acres of paved taxiway preceding Runway 6, and the construction of approximately 0.5 acres of taxiway to connect Runway 6 to the southern taxiway. Pavement replacement of approximately 0.2 acres would occur within the construction limits, along with electrical improvements including taxiway edge lights, new cabling, identifier lights, runway identification signs, and approximately 1.9 acres of reseeding in areas adjacent to ground disturbance.
