**Project Title:** 2019/20 City Bridges and Culverts Structural Inspection and Repairs, Project 20-60 (Lake or Streambed Alteration Agreement No. EPIMS-SCL-44151-R3)

**Project Location (Santa Clara County):** The project is located at Pond 4 of Shoreline Golf Links golf course in Shoreline at Mountain View Regional Park, in the City of Mountain View, County of Santa Clara, State of California; or Section 9, Township 6 South, Range 2 West, U.S. Geological Survey (USGS) map Mountain View, CA, Mount Diablo Base and Meridian or 2940 North Shoreline Boulevard, Mountain View, CA 94043; Assessor's Parcel Number (APN) 116-05-076.

**Project Description:** The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement (EPIMS- SCL-44151-R3), pursuant to Fish and Game Code section 1602, the project Applicant, Joy Houghton/City of Mountain View - Department of Public Works.

The project is limited to work at three locations within the same artificial pond and is focused on the removal of an existing galvanized corrugated culvert and a steel single-span pedestrian bridge, to be replaced with new steel truss structures. One location will involve the construction of new abutments positioned outside the water's edge, while the other will entail the removal and replacement of the existing structure, utilizing the current abutments. Additionally, the project will require excavation of soil at both ends of the existing culvert to create an island feature.


This is to advise that CDFW, acting as a Responsible Agency, approved the project described above on July/01/2025 and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. CDFW considered the **Mitigated Negative Declaration** prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures **were** made a condition of CDFW's approval of the project.
4. A Mitigation Reporting or Monitoring Plan **was not** adopted by CDFW for this project.
5. A Statement of Overriding Considerations was not adopted by CDFW for this project.
6. Findings were not made by CDFW pursuant to California Code of Regulations section 15091.
