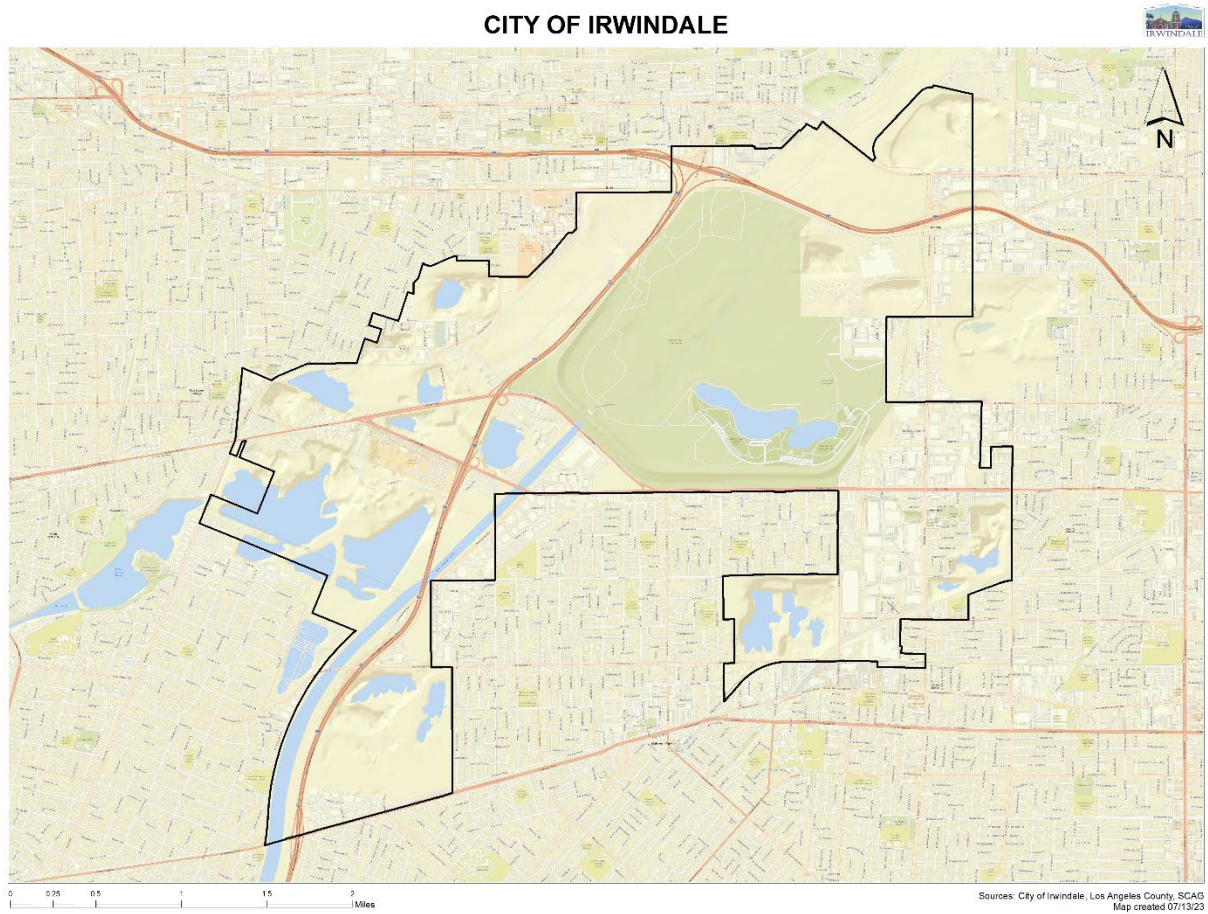

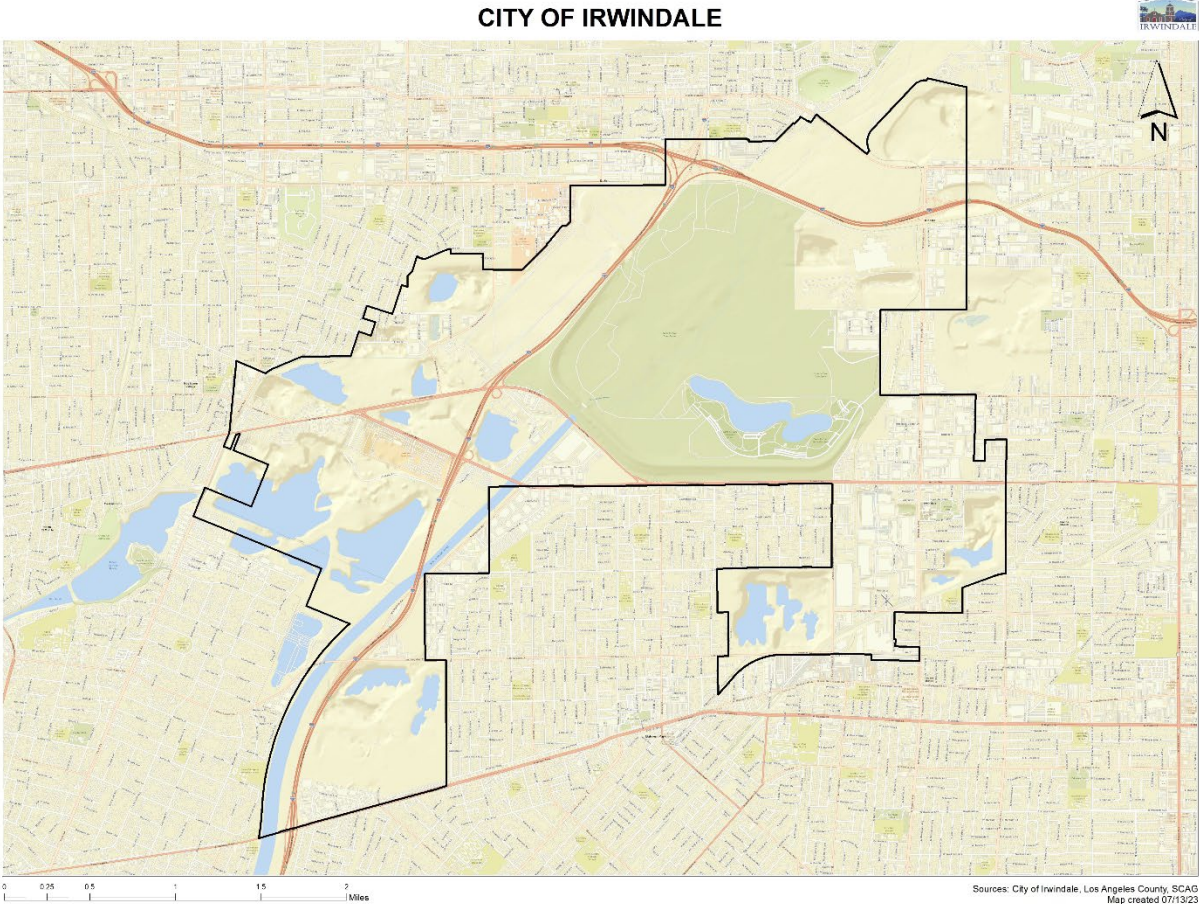

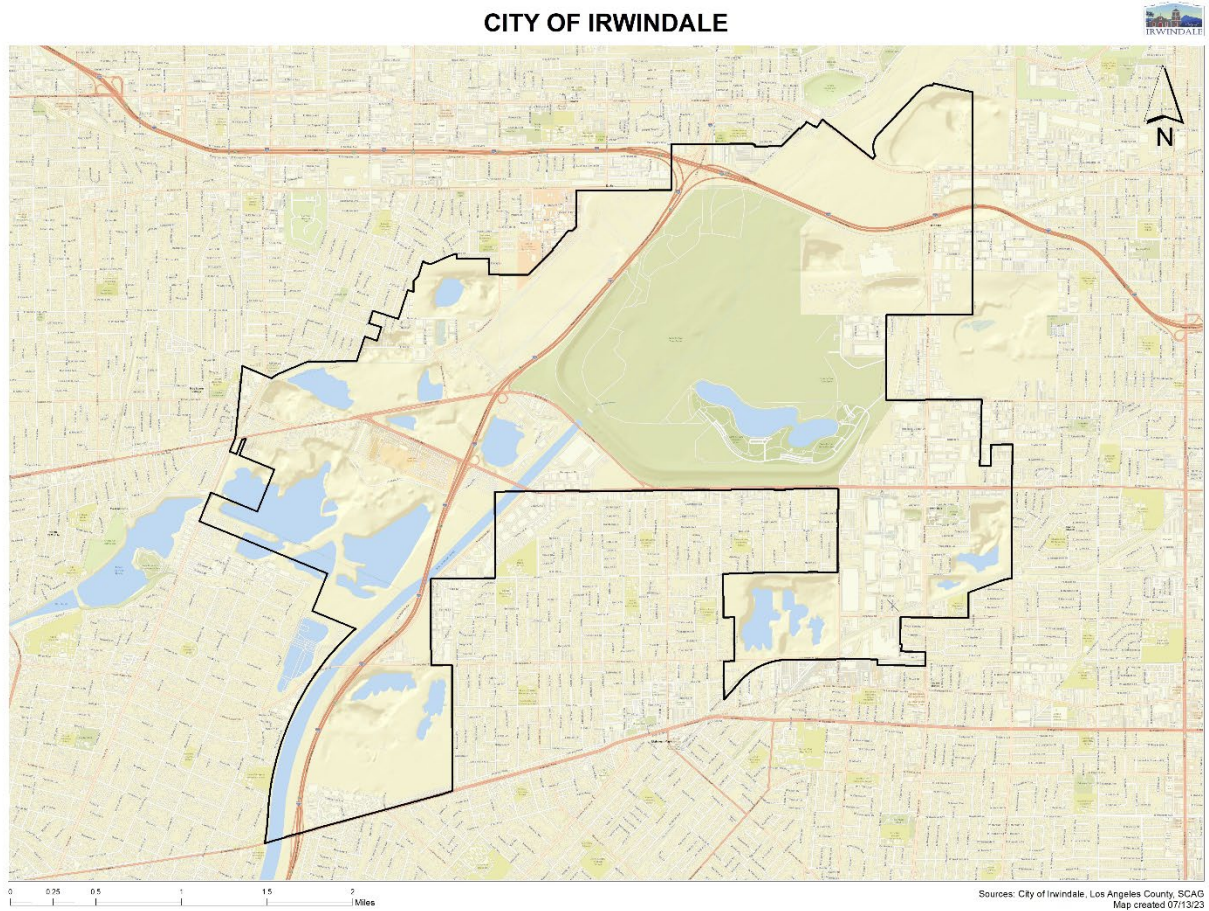

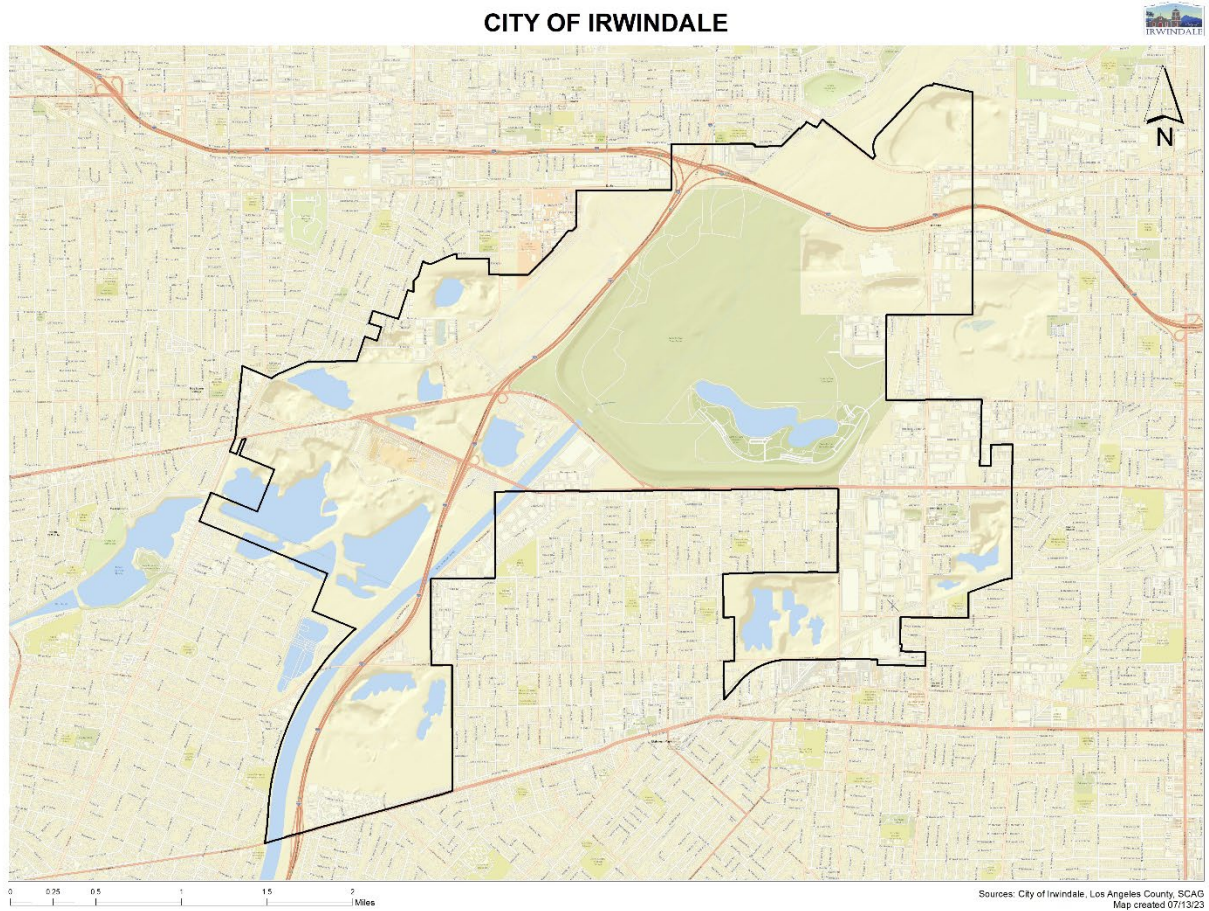

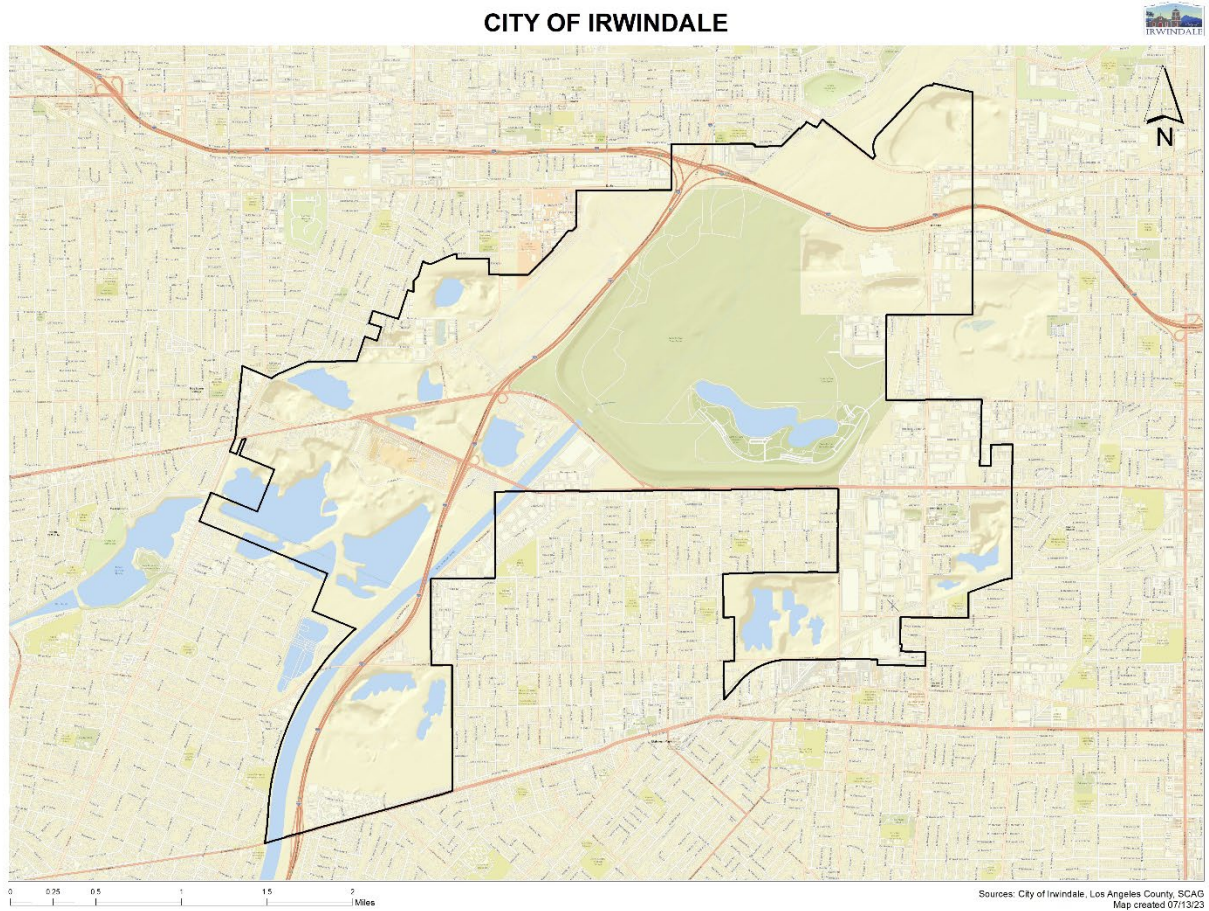

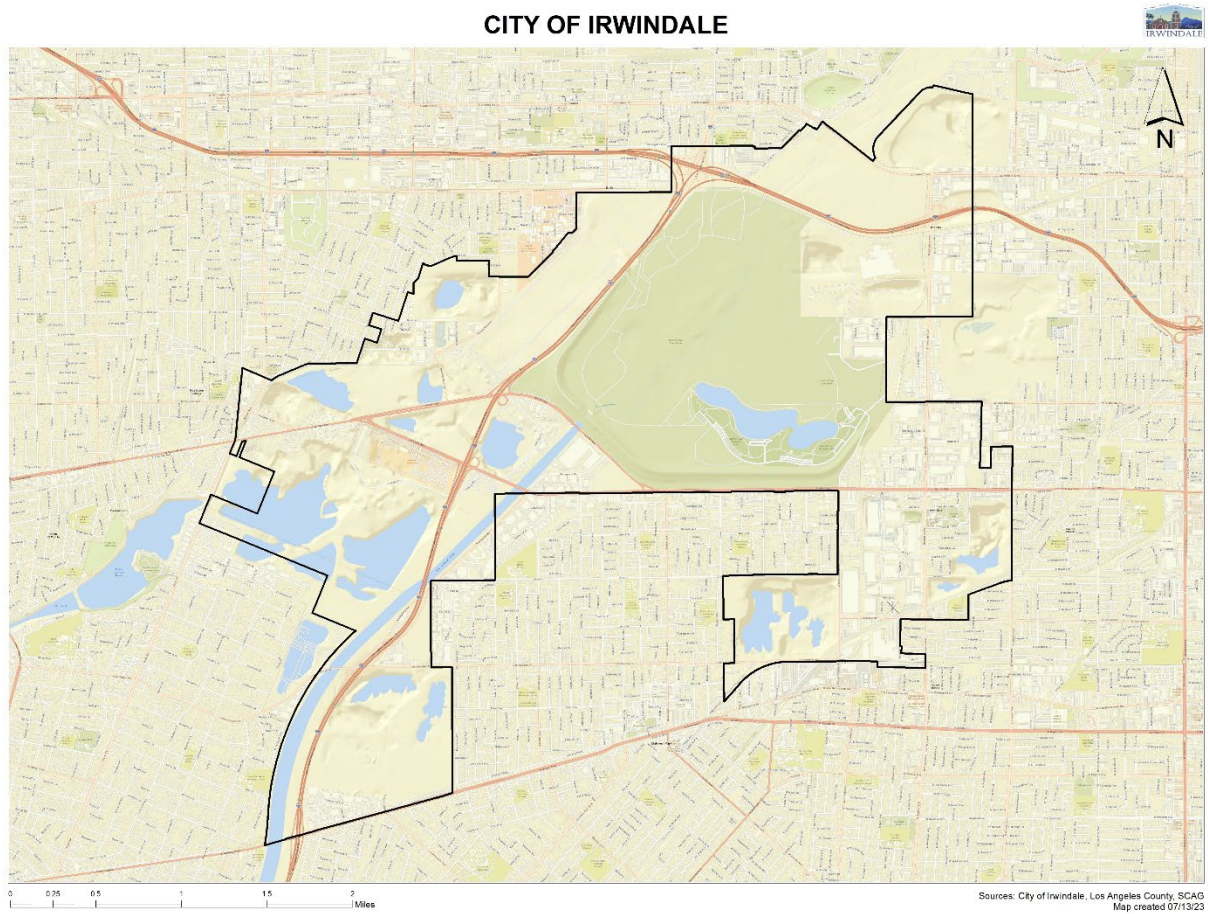

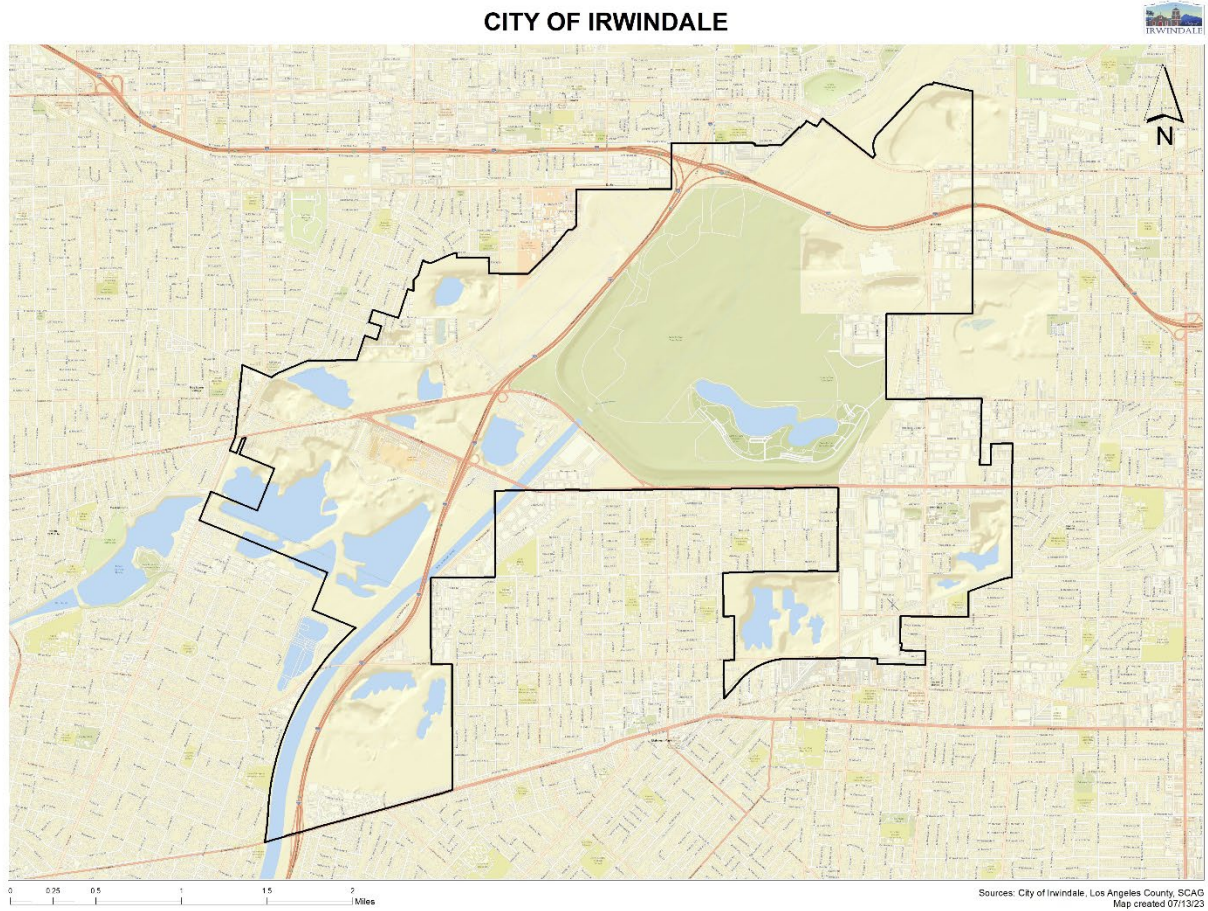

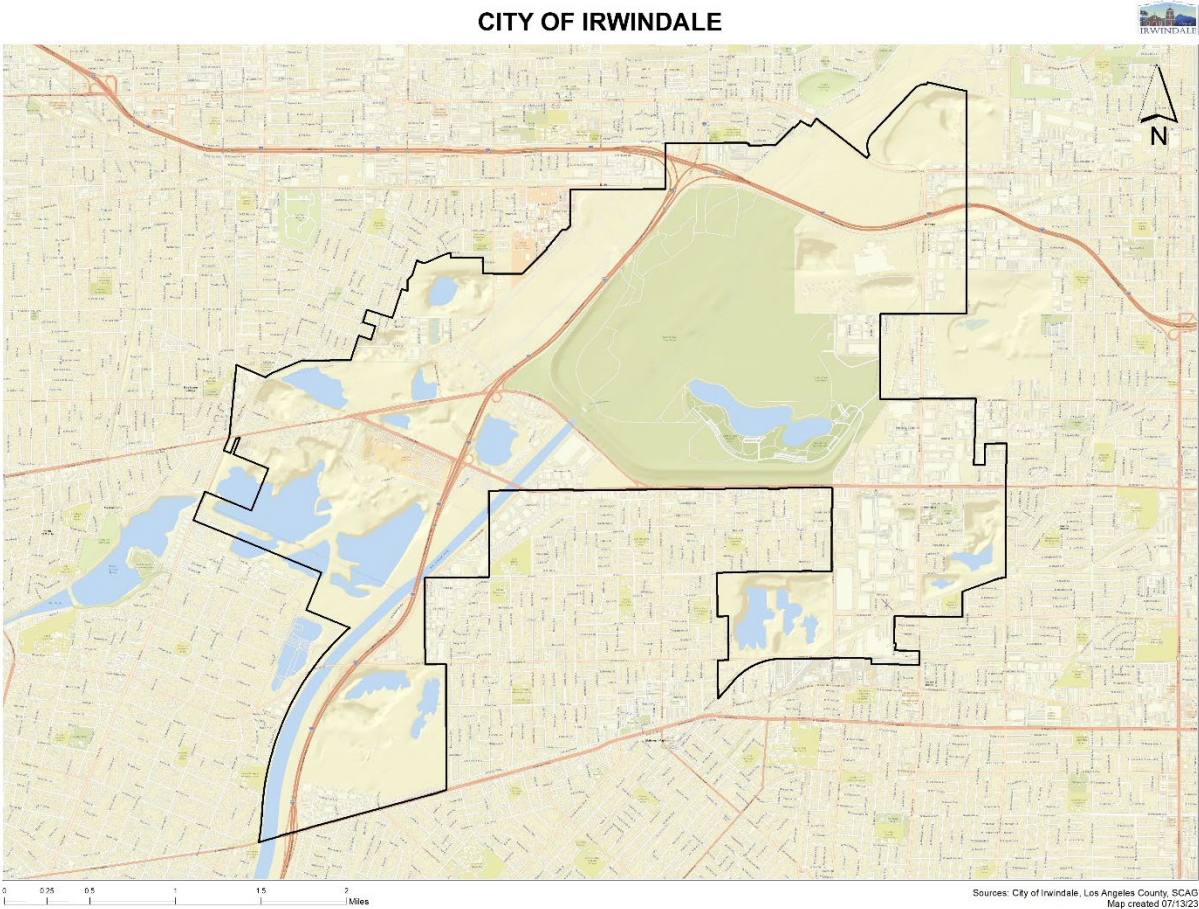

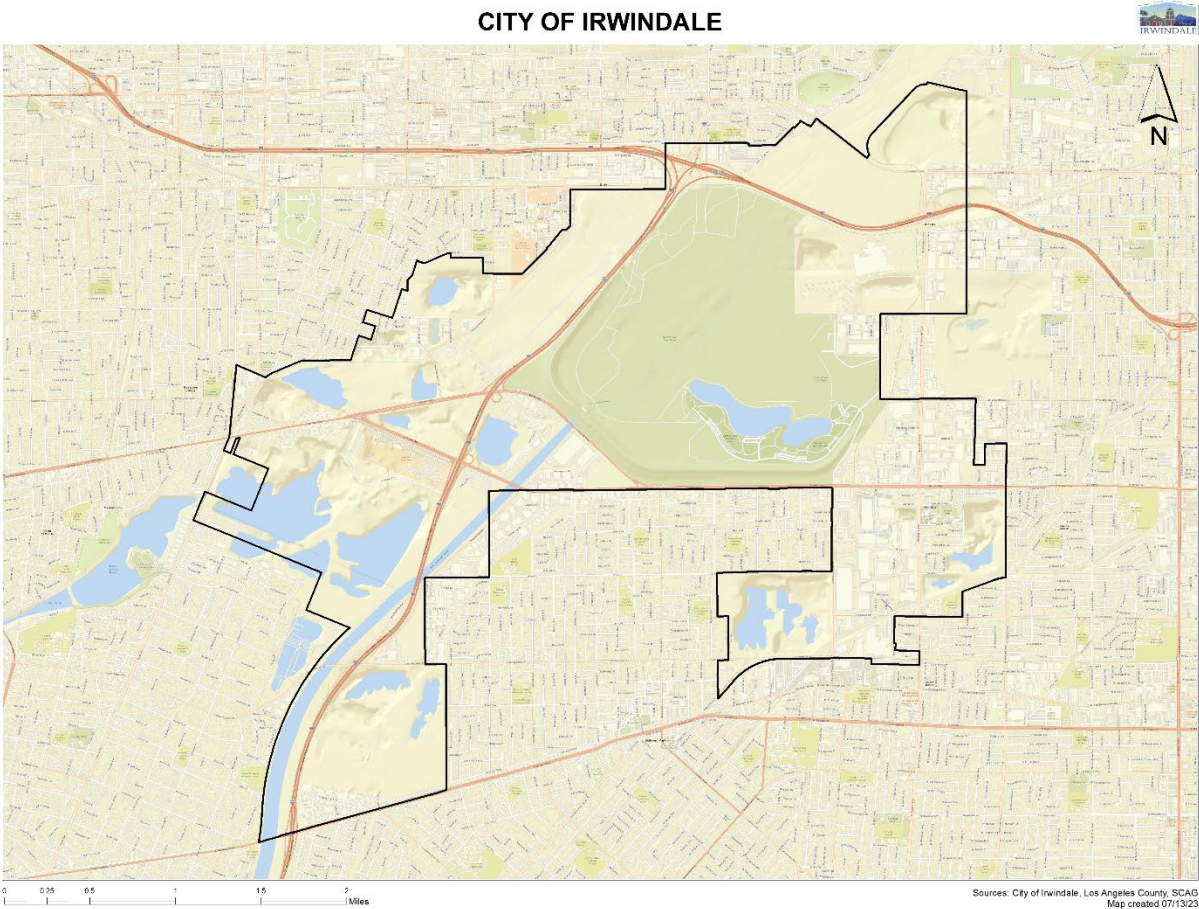

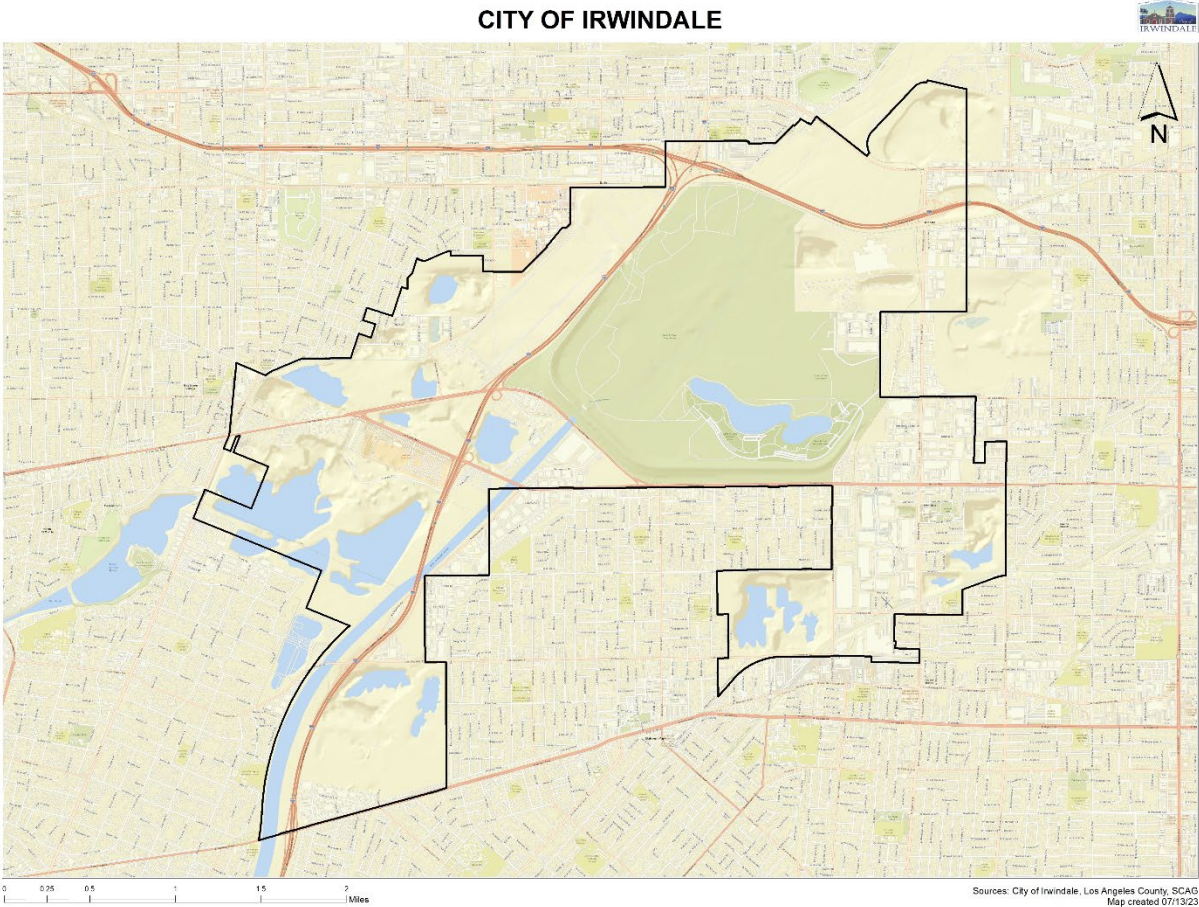

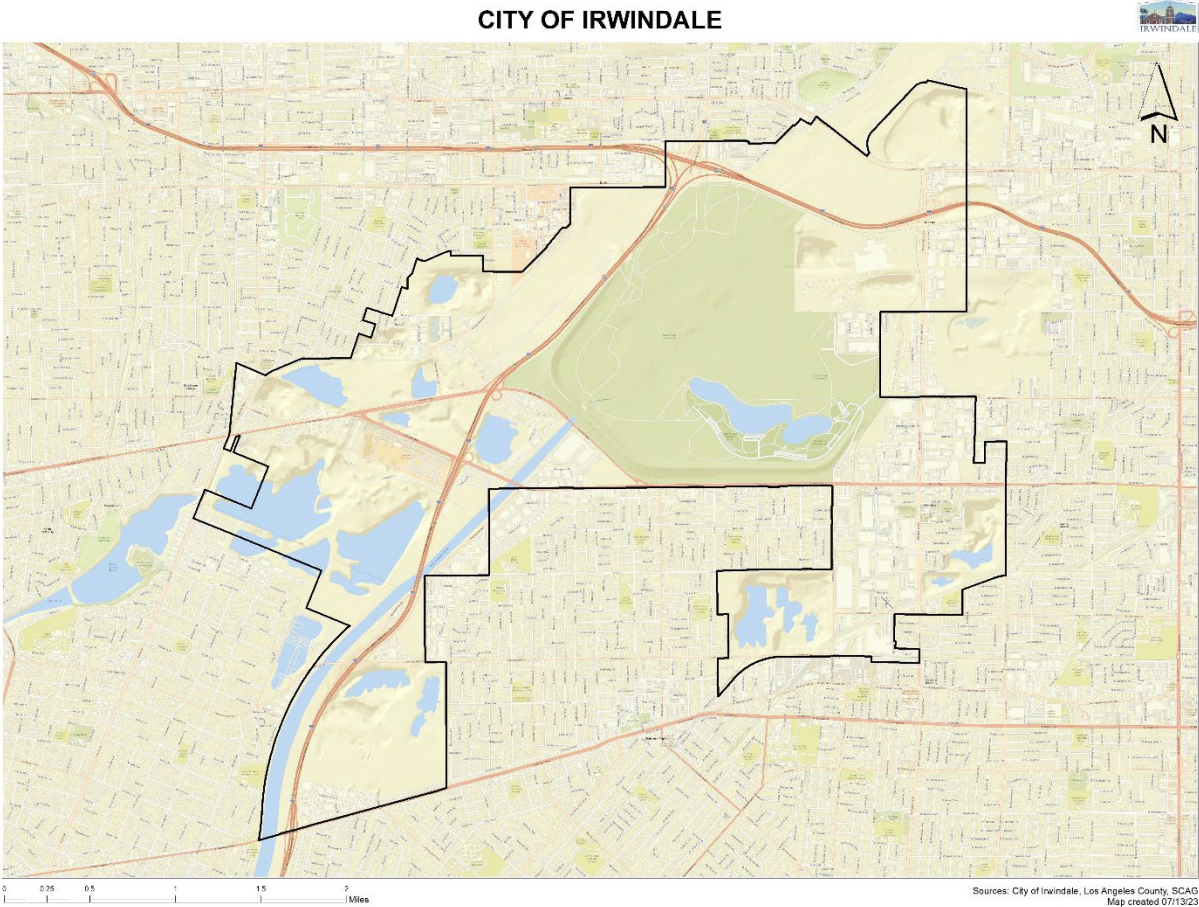

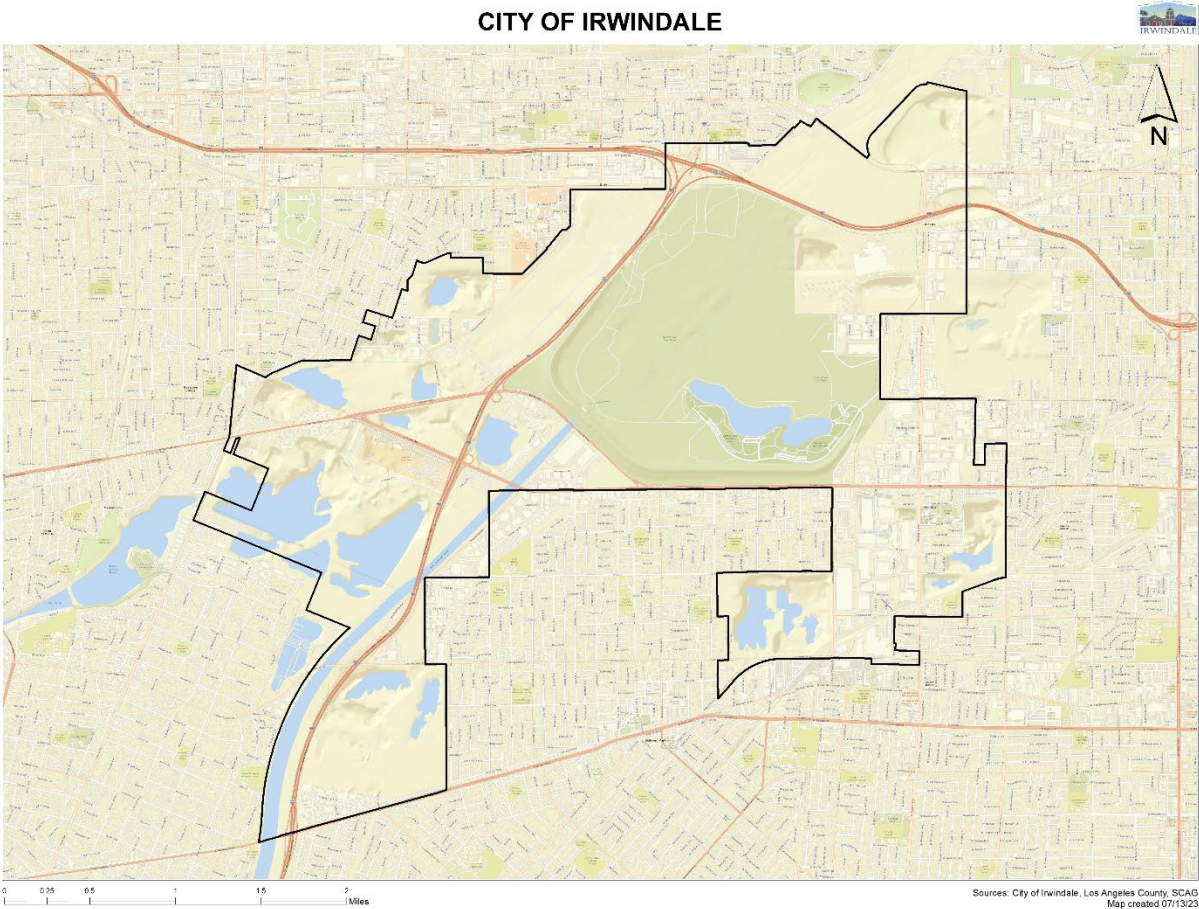

In accordance with State law, the City is in the process of updating the Housing and Safety Element of its current General Plan, as well as preparing a new Environmental Justice Element to be adopted as part of the current General Plan.

The overall purpose of the 2021-2029 Housing Element is to address the housing needs of all types of households and income levels for current and future Irwindale residents. State law requires that the City's 2021 to 2029 Housing Element contain specific contents, including an inventory or list of housing sites at sufficient densities to accommodate a specific number of units at various levels of affordability assigned to the City by the regional government, SCAG. 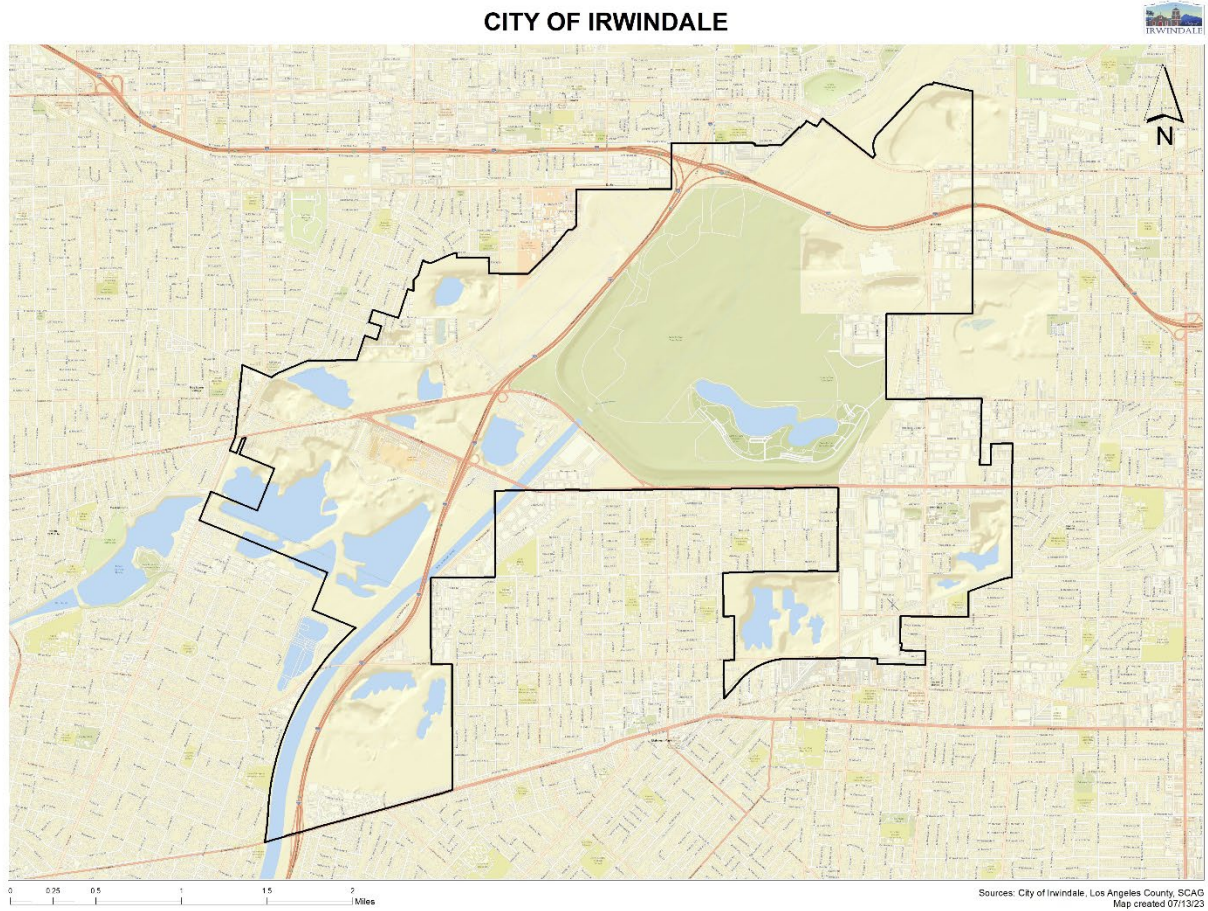

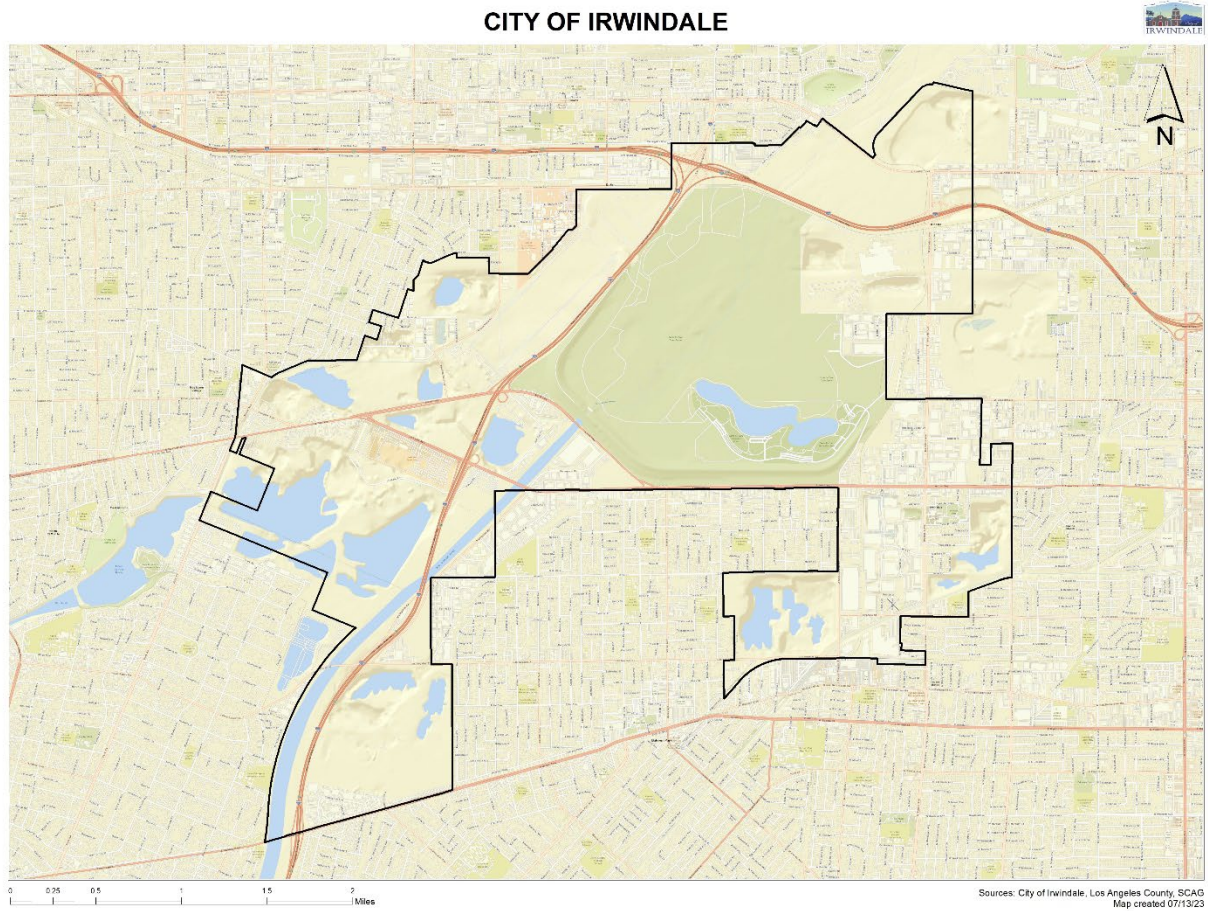
