Project Description (Proposed actions, location, and/or consequences).

The Amendments to the City of Coronado Historic Preservation Program (project) includes adoption of an ordinance amending Title 84 of the Coronado Municipal Code (CMC) and adoption of a Historic Context Statement and Historic Resources Inventory (hereinafter referred to as the Historic Property Survey). Specifically, the project would amend CMC Chapter 84.10, Historic Resource Code, to provide updated criteria for the City's definition and determination of historical significance. Multiple sections of the Historic Resource Code could be revised to remove structures referred to in the Historic Resources Inventory as a Tier 3 property from further historic review.

To inform the proposed Historic Resource Code amendments, the Historic Property Survey was prepared to evaluate properties under CMC Section 84.10.030, Criterion C to identify properties that possess distinctive characteristics of an architectural style that have not been substantially altered (CMC Section 84.10.030(C)). Properties were organized into a tiered system; Tier 3 properties are those substantially altered that retain little to no elements of a particular architectural style and, based on observation and/or construction history, are not eligible for historic designation under Criterion C.

The Historic Property Survey identified a total of 1,667 Tier 3 properties categorized as follows: 1,007 structures built in 1949 or earlier and another 660 structures built between 1950 to 1970.
