Project demolition and construction could have potentially significant impacts associated with disturbance of nesting raptors and migratory birds; adverse changes to cultural and/or tribal cultural resources; exposure of construction workers and nearby sensitive receptors to asbestos-containing materials, lead-based paint coated surfaces, and polychlorinated biphenyls, and contaminated soil and groundwater; exposure of surface waters to contaminated groundwater; generation of noise in excess of City standards; and generation of vibration levels exceeding California Department of Transportation levels for adjacent structurally sensitive buildings.

The project would be required to implement measures that would identify and protect nesting raptors and migratory birds (MM BIO-1.1 and 1.2); identify and protect cultural and tribal cultural resources and human remains (MM CUL-1.1 and 1.2); remove asbestos-containing materials, lead-based paint coated surfaces, and polychlorinated biphenyls prior to demolition (MM HAZ-1.1); address and/or remove contaminated soil and groundwater to the satisfaction of the San Mateo County Environmental Health Services department and in accordance with state and local law (MM HAZ-2.1); implement measures to reduce construction noise below City standards (MM NOI-1.1); and implement measures to reduce vibration below California Department of Transportation levels (MM NOI-2.1). The attached Initial Study/MND determined that with mitigation incorporated, all of the project's potentially significant impacts would be reduced to a less than significant level.
