





Water and wastewater rates, charges, and fees and water service regulations are applicable to the EBMUD service area as shown in Exhibit 1. Real property use application fees are applicable to request for use of EBMUD properties located in the EBMUD service area (shown in Exhibit 1) and in Amador, Calaveras, and San Joaquin Counties (shown in Exhibits 2 and 3). The changes to the recreation use fees apply to EBMUD recreation facilities in the EBMUD service area (shown in Exhibit 1 and in Amador, Calaveras, and San Joaquin Counties (shown in Exhibits 2 and 3). The Board's adoption of these rates, charges, various fees, and regulations is also exempt from the requirements of CEQA because there is no possibility that their adoption will have a significant effect on the environment. All of the rates, charges, and fees adopted by the Board were designed to support the District's operating and capital expenses.
