The SASC would include approximately 180,000 square-feet of new construction, covering a portion of Parking Lot M, west of the Veterans Memorial Stadium. The existing Veterans Stadium will be demolished as part of the Proposed Project, which will include 40,783 square-feet of demolition. The uses of Buildings Q, R, and S (Veterans Stadium) will all be contained within the SASC.

Once the Proposed Project has been approved by the Board of Trustees, project construction is anticipated to begin in June 2026. The Proposed Project will require 15,400 cubic yards of soil export, and 6,600 cubic yards of soil import.

In accordance with Section 21080.3.1(d) of the PRC, the Gabrieleño/Tongva San Gabriel Band of Mission Indians have 30 days from the receipt of this letter to either request or decline consultation in writing for this Project.




Attachment: Figure 1 – Project Location and Vicinity Map
