The Oveja Ranch Solar Project includes construction and operation of a PV solar power and battery storage facility and interconnection facilities, including a generation substation, and interconnection lines, that would provide new power production capacity of up to 75 MW delivered at the point of interconnection with the electrical grid managed by SMUD. The project site would generally comprise PV solar modules, foundation piles, racking, direct current (DC) collection, AC to DC inverters, alternative current (AC) collection, fencing, roads, inverters, medium voltage transformers, an interconnection line between the generation substation, BESS equipment, and interconnection lines to the existing SMUD distribution system. The Oveja Ranch Solar Project also include Williamson Act contract amendments to include solar development as a compatible use.
