Description of Nature, Purpose and Beneficiaries of Project: Levee repairs to address damages caused by overtopping and seepage, including installation of turf reinforcement mat on the landside slopes of the south levee to restore as-built conditions and stabilization of the creek-side levee slope along a 115-foot-long section of the south levee with Rock Slope Protection (RSP). These actions require the use of mechanized equipment from the top of levee to install RSP and reinstall turf reinforcement mats that were damaged during storm occurrences.
