The County of San Luis Obispo (County) Public Works Department proposes to construct a new permanent bridge over Franklin Creek to replace an existing temporary steel truss bridge. The Chimney Rock Road at Franklin Creek Project (project) is located on Chimney Rock Road at the intersection of Fawn Lane, crossing Franklin Creek, in a rural, unincorporated area of the county, approximately 15 miles northwest of U.S. Highway 101 (US 101) and on the southern arm of Lake Nacimiento. The purpose of this project is to provide a permanent two-lane bridge for vehicle crossing to replace a temporary steel truss bridge that was installed in 2023 when the previous permanent roadway was destroyed during winter storms in January and March 2023.
