Project Description: The project consists of the sixth amendment to extend an existing license agreement between County of San Diego and Pinnacle Towers LLC for real property that consists of communications equipment at the existing, County-owned Otay Mountain Regional Communications System (RCS) facility. The amendment will extend the license term ten years to December 31, 2034 and will automatically extend for two renewal periods of five years.

This is to advise that the County of San Diego Board of Supervisors has approved the above-described project on December 10, 2024 (25), and found the project to be exempt from the CEQA under the following criteria:

Activity is exempt from the CEQA because it is not a project as defined in Section 15378.

G 15061(b)(3) - It can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment and the activity is not subject to the CEQA.

Statement of reasons why project is exempt:

The license amendment is categorically exempt from CEQA pursuant to Section 15301: Existing Facilities as it involves extending an existing license for use of an existing regional communications systems facility and minor modifications that would have no permanent effects on the environment and does not involve the expansion or change of the existing use. Further, no exceptions listed in CEQA Guidelines Section 15300.2 apply to the project. Additionally, the project will not impact environmental resources of hazardous or critical concern that are designated, precisely mapped and officially adopted by government agencies; does not contribute to cumulative environmental impact; will not have a significant impact on the environment due to unusual circumstances; does not damage scenic resources within a designated state scenic highway; and is not on the list of Hazardous Waste and Substance Sites pursuant to Section 65962.5 of the Government Code.
