Valley Water is proposing the VPS Upgrade Project to modernize major equipment at the VPS that has reached the end of its useful life and provide operational reliability and flexibility in the raw water conveyance system to meet the projected future demand for treated water. The Project would replace the valves that provide interconnections between raw water pipelines and upgrade the booster pumps. Existing motor controls, electrical power distribution and control systems, and telemetry equipment would be replaced and upgraded. An existing pad-mounted PG&E transformer would be upgraded and a new diesel standby generator would be installed. Construction is anticipated to take 18 months. All work would occur within previously developed areas at the VPS, with most improvements installed inside of existing structures, and in the flow meter vault located in the adjacent maintenance road on the east side of Los Gatos Creek.
