**PROJECT TITLE: Phillips Street Road Construction**

**PROJECT SPONSOR:** County of Riverside Transportation Department

**PROJECT LOCATION:** Community of Good Hope

**PROJECT DESCRIPTION:** The County of Riverside Transportation Department is proposing to pave approximately 1,000 feet of Phillips Street, from Mapes Road to approximately 370 feet south of Estrella Lane, with Hot Mix Asphalt (HMA) concrete. Phillips Street is classified as a Local Road and is currently a dirt road approximately 22 feet wide and will be paved to the proposed road width of 26 feet.

The proposed project will also include:

- Pavement Delineation, pavement markings, and reflectors
- Removal and installation of signs
- Vegetation (Trees and Bushes) Trimming and/or Stump Removal

**ENVIRONMENTAL ANALYSIS:**

The proposed project will take place within the County right-of-way.

This project is subject to compliance with the Western Riverside County MSHCP. In accordance with Section 7 of the Western Riverside County MSHCP, necessary operation and maintenance along existing roadways are considered a covered activity outside/inside of cell criteria area/conservation areas. This project is considered to be operation and maintenance; therefore, it is a covered activity under the Western Riverside County MSHCP.

If tree and/or vegetation removal takes place during the migratory bird breeding season (February 1 – September 1), a preconstruction nesting survey will be conducted pursuant to the Migratory Bird Treaty Act.

**The County of Riverside Transportation Department has found that the above-described project is exempt from the provisions of the California Environmental Quality Act (CEQA), based on the following:**

**Section 15301 (c) – Existing Facilities** – The project proposes to pave approximately 1,000 feet of Phillips Street, from Mapes Road to approximately 370 feet south of Estrella Lane, with Hot Mix Asphalt (HMA) concrete. The project in its entirety is consistent with Section 15301(c) because it does not create additional traffic lanes and involves no expansion of use of the existing roadway and associated facilities.

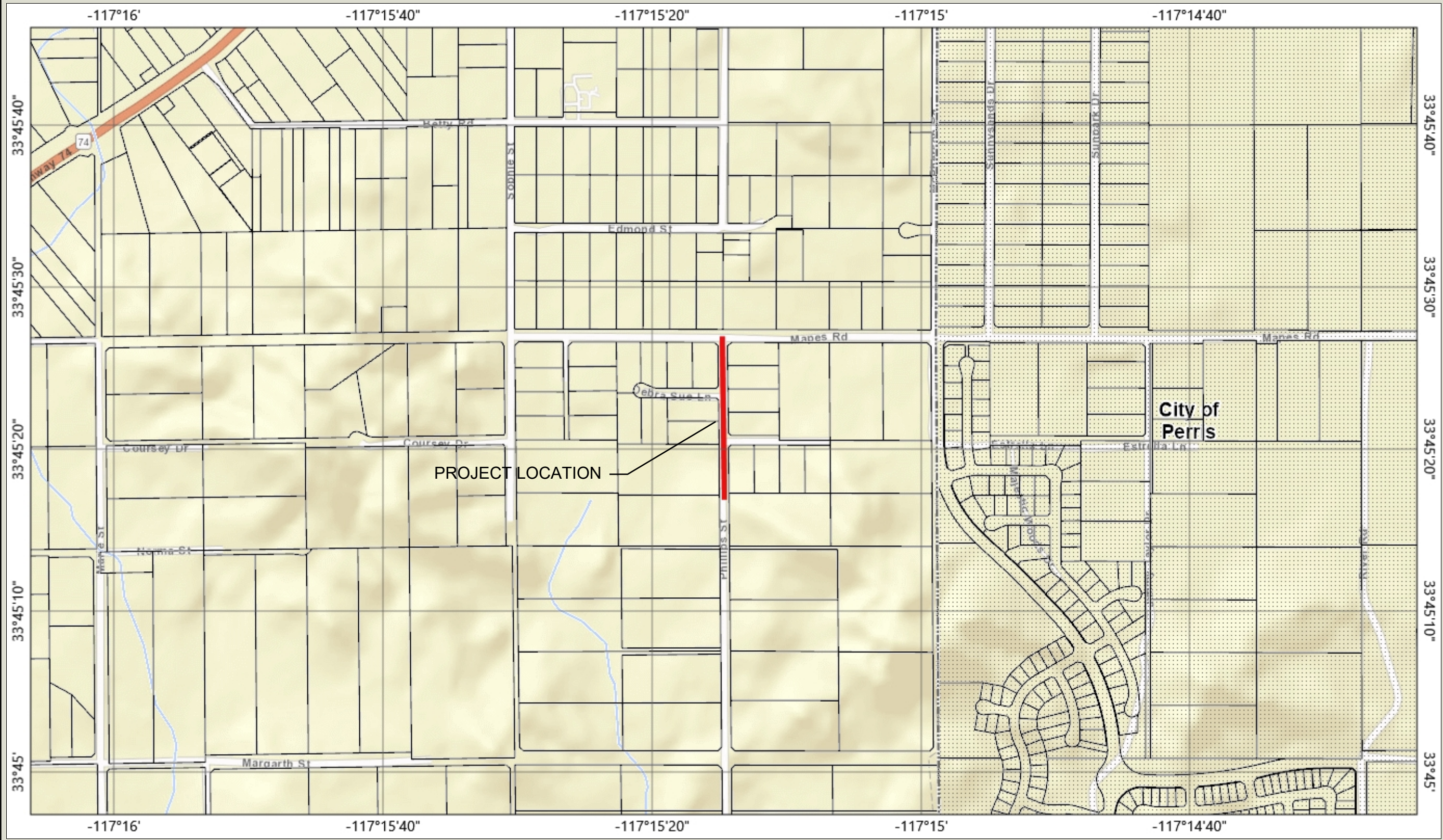
