Description of Nature, Purpose and Beneficiaries of Project

Conduct routine maintenance activities within roadways, drainage facilities, buildings, and other County-owned facilities. Activities may include debris removal, repair, replacement, or other minor upgrade activities that improve flood conveyance, safety on roadways, and other facility functions. Work may include maintenance to culverts, roads, road shoulders, buildings, bridges, and vegetation on County property or within County Right of Way using hand tools or heavy equipment operated from the roadway or road shoulder. Work will not result in significant impacts to jurisdictional areas. During review of the project, no exceptions as described in Section 15300.2 of the CEQA Guidelines were determined to be applicable.
