The Alameda-Tesla Park Classification and General Plan Project would result in a General Plan for the Alameda-Tesla property. The Alameda-Tesla property would be classified at the same time. Classifications come with varying levels of trail systems, interpretive activities, recreation, and overnight lodging. The General Plan will outline the long-term management framework for the property and, depending on the classification outcome, establish the foundation for future park improvements. The General Plan will be based on extensive resource and user information gathered during the planning effort. The General Plan will document existing conditions and establish goals and guidelines that will guide Alameda-Tesla property management and provide long-term direction for the development of future facilities. Where appropriate, the location and extent of potential future facilities will be determined, and associated effects will be analyzed in the EIR.
