The subject parcel is located on the west side of Golden State Boulevard 0.4 miles north of Chestnut Avenue, approximately 0.33-miles east from the City of Fresno. (APN: 330-090-52) (3525 Golden State Boulevard) (Sup. Dist. 3).

Allow a Solid Waste Processing Facility along with a (by right) Ready-Mix Concrete Plant on an existing 12.01acre Parcel. The subject property is located within the M-3 (Heavy Industrial) Zone District.

- 9. Surrounding land uses and setting: Briefly describe the project's surroundings: The surrounding parcels are designated limited industrial and utilized for various industrial uses.

The project was routed to the Dumna Wo Wah Tribal Government, Santa Rosa Rancheria Tachi Yokut Tribe, Picayune Rancheria of the Chukchansi Indians, and Table Mountain Rancheria in accordance with Public Resources Code Section 21080.3.1(b). No tribe expressed any concerns related to Tribal Cultural Resources (TCRs). With adherence to the mitigation measures noted in Section V. Cultural Resources of the Initial Study document, the project will have less than significant impact on tribal cultural resources as defined in Public Resources Code Section 21074.
