Project Description

California Department of Transportation (Caltrans) proposes to improve the Southbound (SB) Maxwell Safety Roadside Rest Area (SRRA) (15R0001L) in Colusa County on southbound Interstate 5 (I-5) at postmile R24.3, approximately 2.5 miles south of Maxwell.

Purpose: The purpose of this project is to extend the operational lifecycle of the existing SB Maxwell SRRA facility while also accommodating future traffic volume demands for the comfort station fixtures.

Need: The existing SB Maxwell SRRA (15R0001L) is in substandard condition due to aging facilities. Current comfort stations are at the end of their functional life cycle and below the minimum restroom fixture count needed to service the growing volume of motorists along I-5.
