RESOLUTION NO. 1501

MAKING CERTAIN DETERMINATIONS RELATED TO THE CALIFORNIA ENVIRONMENTAL QUALITY ACT AND AUTHORIZING STAFF TO FILE NOTICE OF EXEMPTIONS FOR SINGLE POINT OF ENTRY PROJECTS

WHEREAS, the Twin Rivers Unified School District (“District”) is committed to maintaining and improving school facilities to ensure safe, functional, and sustainable learning environments for students and staff; and

WHEREAS, the following Single Point of Entry Projects (“Projects”) were board approved on April 8, 2025: Martin Luther King Junior Technology Academy Single Point of Entry Project, and Multi-Site Highlands High School & Rio Tierra Junior High School Single Point of Entry Project; and

WHEREAS, the scope of each project is as follows:

- **Martin Luther King Junior Technology Academy Single Point of Entry Project:** The construction of the new single point of entry way for the campus. This includes the construction of new gates and secure gateways, as well as Americans with Disabilities Act (“ADA”) improvements to site pathways, small-scale beautification, and all associated required paving.
- **Multi-Site Highlands High School & Rio Tierra Junior High School Single Point of Entry Project:**
 - The Highlands High School Project includes the installation of aluminum-framed entry and storefront systems at the administrative and office in building A to provide a new single point of entry at Highlands High school.
 - The Rio Tierra Junior High School Project includes the installation of aluminum-framed entry and storefront systems at the administrative office in building C to provide a new single point of entry at Rio Tierra Junior High School. Site improvements to support the new single point of entry include all necessary flatwork and ornamental iron fencing and gates; and

WHEREAS, the California Environmental Quality Act (“CEQA”) (Pub. Resources Code, § 21000 et seq.) and the State CEQA Guidelines (14 CCR § 15000 et seq.) require public agencies to evaluate the environmental impacts of proposed projects before approving them; and

WHEREAS, the District has determined that each of the above-named Projects are categorically exempt from CEQA under one or more applicable exemption as set forth in the CEQA Guidelines, as described below:

Class 1 Exemption (Section 15301): Applies to the operation, repair, maintenance, or minor alteration of existing facilities, involving negligible or no expansion of use beyond that previously existing; and

WHEREAS, there is no evidence of any unusual circumstances or significant environmental impacts that would preclude the use of this categorical exemption under CEQA Guidelines Section 15061(b)(1-5); and

WHEREAS, District staff or designee will file a Notice of Exemption for each above-named Project and any required supporting documents (Exhibit A) with the Sacramento County Clerk and the State Clearinghouse in compliance with CEQA Guidelines Section 15062; and

NOW, THEREFORE, BE IT RESOLVED that Twin Rivers Unified School District in Sacramento County, California, hereby issues this Resolution that determines, declares, and resolves as follows:

1. The above-named Projects are categorically exempt from CEQA pursuant to the applicable exemption listed above.
2. The Projects are as described in the scope above.
3. The District considered whether each Project would have significant impact on the environment and determined that no such impact exists based on its review and analysis.
4. The District's Superintendent or designee thereof is directed to file the Notice of Exemption from CEQA consistent with this resolution, attached hereto as Exhibit A, with any and all appropriate public agencies or entities, subject only to minor, non-substantive revisions, if necessary.


