NOTICE OF EXEMPTION

Project Title: PG&E HDD Project at Salmon Creek (35056808 R20A) - 2025 (Notification of Lake or Streambed Alteration, No. EPIMS-SON-55357-R3)

Project Location (Sonoma County): The project is located at Salmon Creek and an unnamed tributary to Salmon Creek at approximately Latitude 38.37256, Longitude - 122.91417 and Latitude 38.37270, Longitude -122.91358.

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement EPIMS Notification No. EPIMS-SON-55357-R3, pursuant to Section 1602 of the Fish and Game Code to Pacific Gas and Electric Company as represented by Jeremiah Davis.

The project is limited to installation of a PG&E electrical line approximately 10 feet beneath Salmon Creek and the unnamed tributary to Salmon Creek using a horizontal directional drill (HDD). In conjunction with the HDD, the Permittee will remove trash for 0.5 miles upstream and downstream of the bridge at the Salmon Creek.
