RESOLUTION NO. 1502

MAKING CERTAIN DETERMINATIONS RELATED TO THE CALIFORNIA ENVIRONMENTAL QUALITY ACT AND AUTHORIZING STAFF TO FILE NOTICE OF EXEMPTIONS FOR OUTDOOR LEARNING SHADE STRUCTURE PROJECTS

WHEREAS, the Twin Rivers Unified School District (“District”) is committed to maintaining and improving school facilities to ensure safe, functional, and sustainable learning environments for students and staff; and

WHEREAS, the Fairbanks Elementary School Outdoor Learning Shade Structure Project was board approved on February 25, 2025; and

WHEREAS, the Strauch Elementary School Outdoor Learning Shade Structure Project was board approved on April 8, 2025; and

WHEREAS, the scope of each project is as follows:

- **Fairbanks Elementary School Outdoor Learning Shade Structure:** Includes the installation of one 30’ x 64’ metal shade structure that will be positioned behind building E, the installation of one hi-low drinking fountain, American with Disabilities Act (“ADA”) restroom and pathway compliance improvements, and all required sitework for project completion.
- **Strauch Elementary Outdoor Learning Shade Structure Project:** Includes the installation of one 30’ x 64’ metal shade structure that will be positioned near buildings D and E, and the required site work for project completion; and

WHEREAS, the California Environmental Quality Act (“CEQA”) (Pub. Resources Code, § 21000 et seq.) and the State CEQA Guidelines (14 CCR § 15000 et seq.) require public agencies to evaluate the environmental impacts of proposed projects before approving them; and

WHEREAS, the District has determined that the above-named Projects are categorically exempt from CEQA under one or more applicable exemption as set forth in the CEQA Guidelines, as described below:

1. **Class 1 Exemption (Section 15301):** Applies to the operation, repair, maintenance, or minor alteration of existing facilities, involving negligible or no expansion of use beyond that previously existing; and/or
2. **Class 3 Exemption (Section 15303):** Applies to construction and location of limited numbers of new, small facilities or structures; installation of small new equipment and facilities in small structures; and the conversion of existing small structures from one use to another where only minor modifications are made in the exterior of the structure; and

WHEREAS, there is no evidence of any unusual circumstances or significant environmental impacts that would preclude the use of these categorical exemptions under CEQA Guidelines Section 15061(b)(1-5); and

WHEREAS, District staff or designee will file a Notice of Exemption for each above-named Project and any required supporting documents (**Exhibit A**) with the Sacramento County Clerk and the State Clearinghouse in compliance with CEQA Guidelines Section 15062.

NOW, THEREFORE, BE IT RESOLVED that Twin Rivers Unified School District in Sacramento County, California, hereby issues this Resolution that determines, declares, and resolves as follows:

1. The above-named Projects are categorically exempt from CEQA pursuant to the applicable exemptions listed above.
2. The Projects are as described in the scope above.
3. The District considered whether each Project would have significant impact on the environment and determined that no such impact exists based on its review and analysis.
4. The District's Superintendent or designee thereof is directed to file the Notice of Exemption from CEQA consistent with this resolution, attached hereto as **Exhibit A**, with any and all appropriate public agencies or entities, subject only to minor, non-substantive revisions, if necessary.
