RESOLUTION NO. 1500

MAKING CERTAIN DETERMINATIONS RELATED TO THE CALIFORNIA ENVIRONMENTAL QUALITY ACT AND AUTHORIZING STAFF TO FILE NOTICE OF EXEMPTIONS FOR FENCING PROJECTS

WHEREAS, the Twin Rivers Unified School District (“District”) is committed to maintaining and improving school facilities to ensure safe, functional, and sustainable learning environments for students and staff; and

WHEREAS, the following fencing projects (“Projects”) were board approved on April 8, 2025: D.W. Babcock Elementary School Fencing Project, Dry Creek Elementary School Fencing Project, Regency Park Elementary School Fencing Project, and Vineland Preschool Fencing Project; and

WHEREAS, the Sierra View Elementary Fencing Project was board approved on March 11, 2025; and

WHEREAS, the scope of each project is as follows:

- **D.W. Babcock Elementary School Fencing Project:** The construction of new concrete flatwork, mow band, and construction of 6-foot black vinyl chain link fence and gates to separate the school campus from the Babcock Park.
- **Dry Creek Elementary School Fencing Project:** The replacement of chain link fence with 6-foot galvanized fence and gate and the required concrete flatwork to secure the kindergarten play area on campus.
- **Regency Park Elementary School Fencing Project:** The placement of new 6-foot black vinyl chain link fence and maintenance gate near the south-west play area on campus.
- **Sierra View Elementary School Fencing Project:** The construction of 6-foot ornamental fencing and gates with the required concrete flatwork to provide a compliant path of travel near the kindergarten play area on campus.
- **Vineland Preschool Fencing Project:** The construction of 6-foot ornamental fencing and gates along the school frontage, and adding additional pedestrian egress and maintenance gates. All pedestrian gates in a known or potential means of egress will include panic hardware; and

WHEREAS, the California Environmental Quality Act (“CEQA”) (Pub. Resources Code, § 21000 et seq.) and the State CEQA Guidelines (14 CCR § 15000 et seq.) require public agencies to evaluate the environmental impacts of proposed projects before approving them; and

WHEREAS, the District has determined that each of the above-named Projects are categorically exempt from CEQA under one or more applicable exemption as set forth in the CEQA Guidelines, as described below:

1. **Class 1 Exemption (Section 15301)**: The operation, repair, maintenance, permitting, leasing, licensing, or minor alternation of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of existing or former use.
2. **Class 3 Exemption (Section 15303)**: The construction and location of limited numbers of new, small facilities or structures; installation of small new equipment and facilities in small structures; and the conversion of existing small structures from one use to another where only minor modifications are made in the exterior of the structure; and

WHEREAS, there is no evidence of any unusual circumstances or significant environmental impacts that would preclude the use of these categorical exemptions under CEQA Guidelines Section 15061(b)(1-5); and

WHEREAS, District staff or designee will file a Notice of Exemption for each above-named Project and any required supporting documents (**Exhibit A**) with the Sacramento County Clerk and the State Clearinghouse in compliance with CEQA Guidelines Section 15062; and


NOW, THEREFORE, BE IT RESOLVED that Twin Rivers Unified School District in Sacramento County, California, hereby issues this Resolution that determines, declares, and resolves as follows:

1. The above-named Projects are categorically exempt from CEQA pursuant to the applicable exemptions listed above.
2. The Projects are as described in the scope above.
3. The District considered whether each Project would have significant impact on the environment and determined that no such impact exists based on its review and analysis.
4. The District's Superintendent or designee thereof is directed to file a Notice of Exemption from CEQA consistent with this resolution, attached hereto as **Exhibit A**, with any and all appropriate public agencies or entities, subject only to minor, non-substantive revisions, if necessary.




