The project proposes to allow the construction and operation of an Agricultural Commercial Center, consisting of an approximately 7,058 square-foot convenience store and fast-food restaurant, along with two fueling islands, on a portion of a 3.28-acre parcel in the AE-20 (Exclusive Agricultural, 20-acre minimum parcel size) Zone District.
8. **Surrounding land uses and setting: Briefly describe the project's surroundings:**
The proposed project is located in an area of agricultural uses and very low-density residential development.


