Project Title: SOULSOL LLC (Project)

Project Location: The Project is located at 79431 Highway 271 (APN 053-120-07-00) in Piercy, CA.

County: Mendocino

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Section 26012, approved a Small Outdoor commercial cannabis license submitted on 1/13/2025 by Felipe Guarderas.

Project Activities: The Project will consist of cannabis cultivation on an existing site located at 79431 Highway 271 (APN 053-120-07-00). This project was issued Mendocino County cultivation permit C-2018-0178 on 11/14/2023. The site is zoned Urban Residential (UR:40) and has previously been used for agriculture. This site now includes cannabis production with no plans for future expansion. Activities that take place include cannabis cultivation, drying, curing, weighing, trimming, disposal, and storage. The project would continue to source water from an onsite rainwater catchment, there is onsite septic for wastewater, and power is provided by an onsite solar array.
