The project is a grading permit and development plans for a boat and RV storage facility within parcel 208-0022-002-0000, which is 9.12 acres and zoned M-1. The parking area will occupy also the entire parcel. The parking area will include security lighting and will not have any on-site office space developed. The project will also have a water quality basin in parcel 208-0012-017-0000 which is 4.38 acres and zoned AR-5. The basin will be approximately 9 feet in depth and is approximately 576 square feet of the parcel with the remainder being undeveloped.
