Project Title: Red Hawk Ridge (Project)

Project Location: The Project is located at 13037 Tyler Foote Crossing Road in Nevada County.

County: Nevada County

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Division 10, Chapter 2, Section 26012, approved a Medium Outdoor commercial cannabis license.

Project Activities: The project is located on two rural parcels, 36.43-acres and 38.38-acres in size, under common ownership in an agricultural zoning district (AG-40). This project approval is for 19,424 square feet of mixed-light mature canopy and 10,238 square feet of outdoor mature canopy for a total of 29,662 square feet of mature canopy area, and a total of 2,790 square feet of support over a course of two (2) phases. Activities that take place include cannabis cultivation, drying, curing, trimming, disposal, and storage. The project will use a well onsite to source water and power is provided by local utility provider.

Reasons Why Project is Exempt: The Department of Cannabis Control has determined that the project is consistent with the local jurisdiction community plan and/or zoning designations. On May 14, 2019, Nevada County Resolution No. 19-199 certified a Program Environmental Impact Report (PEIR; SCH #2018082023) for the Nevada County Commercial Cannabis Cultivation Ordinance. On January 10, 2023, the Nevada County Board of Supervisors adopted an Addendum to the certified PEIR which analyzed potential impacts associated with amendments to the Nevada County Commercial Cannabis Cultivation Ordinance. CEQA mandates that the project is consistent with the development density established by existing zoning, community plan, or general plan policies for which an EIR was certified and shall not require additional environmental review, except as might be necessary to examine whether there are project-specific significant effects which are peculiar to the project or its site. The project activity fits within the parameters included in CEQA Guidelines Section 15183 and the activity does not require additional CEQA analysis.
