Project Location: The Project is located at 73980 Dobie Lane (APN 034-270-53-00) in Covelo, CA.

County: Mendocino

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Section 26012, approved a Small Mixed-Light Tier 1 commercial cannabis license submitted on 11/7/2024 by Michael Admoni.

Project Activities: The Project will consist of cannabis cultivation on an existing site located at 73980 Dobie Lane (APN 034-270-53-00). This project was issued Mendocino County cultivation permit CAN-C-2023-001 on 10/18/2023. The site is zoned Agriculture (AG 40) and has been used for cattle grazing since at least 1980. This site now includes cannabis production with no plans for future expansion. Activities that take place include cannabis cultivation, drying, curing, weighing, trimming, disposal, and storage. The project would continue to source water from an onsite well, there is onsite septic for wastewater, and power is provided by the local utility provider.
