Project Description

The California Department of Transportation (Caltrans) initiated a Director's Order for the purpose of repairing damage to drainage systems and slopes caused by winter storms that occurred from December 2024 through February 2025. This project is needed to prevent further damage to state-owned assets and to protect the integrity of the affected roadway located on State Route 70 from post mile (PM) 36.42 to PM 42.35 in Butte County. Caltrans proposes mobilization, grind/pave asphalt concrete (AC) pavement, place rock slope protection (RSP), rock scaling, remove corrugated metal pipe (CMP) culverts and install reinforced concrete pipe (RCP) culverts, drainage repairs, striping, traffic control, and incidental work.
