The California Department of Transportation (Caltrans) proposes to enhance crosswalk markings at 7 locations on State Route 49 at Postmiles (PM) 3.43, 3.62, 4.32, 4.566, 6.099, 6.375, and 6.98. The scope of work includes replacing traditional markings with ladder patterns. There will be no trenching only grinding of existing paint. All work will be within Caltrans Right of Way. The purpose of the project is to address the outdated crosswalk markings. The project is needed to improve pedestrian crossing visibility.

General:

- If human remains are discovered, State Health and Safety Code Section 7050.5 states that further disturbances and activities shall cease in any area or nearby area suspected to overlie remains, and the County coroner contacted. Pursuant to Public Resources Code Section 5097.98. If the remains are thought to be Native American, the coroner will notify the Native American Heritage Commission (NAHC) who will then notify the Most Likely Descendent (MLD). At the same time the landowner will work with the MLD on the respectful treatment and disposition of the remains. Further provisions of PRC 5097.98 are to be followed as applicable.

- Caltrans Standard Specification (SSP) 84-9.03B will be added to the construction contract for removing non-hazardous striping/pavement markings.
