**Project Description**

The California Department of Transportation (Caltrans) initiated a Director’s Order for an emergency project with the purpose of replacing and upgrading the effectiveness of security infrastructure at four Caltrans Maintenance Stations located in Butte and Yuba Counties. This project is needed to provide more effective perimeter security due to repeated acts of intrusion, theft and vandalism at the Maintenance Stations, and to promote increased safety and wellbeing of Caltrans workers at these facilities. The proposed scope of work includes mobilization, remove and replace existing security fencing and gates with new vandal-deterrent fence and gates, install new security systems including new cameras, and install new security lighting. Additional location information is provided on page 3.
