The proposed project involves the demolition of three existing on-site commercial structures. The site will be redeveloped to support a new commercial center consistent with the City's General Plan land use designation and zoning classification. The four proposed commercial buildings will consist of the following uses: (1) a 5,596 square-foot convenience store ("C-Store") with an associated 6,333-square-foot fuel canopy accommodating sixteen vehicle fueling stations; (2) a 2,976-square-foot quick service restaurant with a drive-through lane; (3)
