**NOTICE OF PUBLIC REVIEW AND INTENT TO ADOPT A  
NEGATIVE DECLARATION**

(State CEQA Guidelines, sections 15072 and 15073)

A Negative Declaration (ND) has been prepared by the California State Lands Commission (CSLC), as lead agency under the California Environmental Quality Act (CEQA) (Pub. Resources Code, § 21000 et seq.) in response to an application submitted by Vulcan Materials Company for the Vulcan Materials New Dredging Project in the Petaluma River (Project). The ND was prepared in compliance with the requirements of CEQA, the State CEQA Guidelines (Cal. Code Regs., tit. 14, § 15000 et seq.), and CSLC regulations (Cal. Code Regs., tit. 2, § 2901 et seq.).

**Project Title:** Vulcan Materials New Dredging Project

**Project Location:** The Project area includes a dredging area located in the Petaluma River, adjacent to 210 Landing Way in the city of Petaluma, California, and transport routes through the San Francisco Bay. See Project Description, below, for further details.

**Project Description:** Vulcan Materials Company would perform 2,519 cubic yards of new dredging in a 0.5-acre area in the Petaluma River at the vessel berth area adjacent to Vulcan Materials property. The dredged sediment would be transported by barge to an existing authorized sediment disposal site in the San Francisco Bay region under the purview of the San Francisco Bay Dredge Materials Management Office, which includes the San Pablo Bay Disposal Site (SF-10), the Cullinan Ranch Restoration Project site, and the Montezuma Wetlands Restoration Project site. Any debris encountered during dredging would be disposed at the Ox Mountain Landfill in Half Moon Bay.
