The proposed project consists of the construction of a new 50-foot-tall Wireless Communication Facility (WCF) within a lease area of about 540 square feet, located on the east side of the tennis courts at Tetotom Park. Site access is proposed via a new driveway connection to the park's existing internal roadways, extending from the parking lot located along Heartland Drive.
