Description of Nature, Purpose, and Beneficiaries of Project: Notice of Exemption for Minor Modification No. MIM 25-011 for the allowance to update the site plan to remove two (2) building and to replace them with eight (8) new buildings to the existing established Private School Facility, in the AE-20 (Exclusive Agriculture – 20 Acre Minimum) Zone, within the Rural Valley Lands Plan, with the Land Use Designation of Valley Agriculture.



Reasons why project is exempt: This action is consistent with Section 15061 (b)(3), The Common Sense Rule, whereas the allowance to update the site plan can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment, the activity is not subject to CEQA. This is because the Minor Modification is merely updating a site plan to allow the remove two (2) building and to replace them with eight (8) new buildings to the existing established Private School Facility to the existing Special Use Permit, in the AE-20 (Exclusive Agriculture – 20 Acre Minimum) Zone, within the Rural Valley Lands Plan, with the Land Use Designation of Valley Agriculture, which were approved by Special Use Permit No. 95-054 (ZA). The use has already been through a CEQA review by way of an approved Notice of Exemption, that was approved by the Tulare County Zoning Administrator on August 9, 1995, Decision No. 1881. Therefore, the application of CEQA Section 15061(b)(3) is applicable and appropriate for this project.
