Notice is hereby given that the County of Fresno has prepared Initial Study (IS) No. 8482 pursuant to the requirements of the California Environmental Quality Act for the following proposed project:

INITIAL STUDY NO. 8482 and VARIANCE NO. 4156 filed by **ORLANDO RAMIREZ, RAMIREZ LAND PLANNING** proposing to allow the creation of one substandard size parcel (1.27-acres) and a 38.11-acre parcel from an existing 39.38-acre parcel in the AE-20 (Exclusive Agricultural, 20-acre minimum parcel size) Zone District. The subject parcel is located on the north side of E. Caruthers Ave., approximately 0.25-miles east from the intersection with south De Wolf Ave., approximately 0.9-miles south of the City of Selma. (APN: 385-102-02s) (8420 E. Caruthers Ave.) (Sup. Dist. 4).

(hereafter, the "Proposed Project")

The County of Fresno has determined that it is appropriate to adopt a Negative Declaration for the Proposed Project. The purpose of this Notice is to (1) provide notice of the availability of IS No. 8381 and draft Negative Declaration and request written comments thereon; and (2) provide notice of the public hearing regarding the Proposed Project.
