Project Title: Streambed Alteration Agreement No. EPIMS-MEN-59189-R1 for Timber Harvesting Plan (THP) 1-25-00031-MEN

Project Location: The project is located approximately 3 miles west of Comptche in Mendocino County on the Middle Albion River, South Fork Albion River, and unnamed tributaries. The project is located in Sections 5, 8, 9, 17, and 21, Township 16N, Range 16W; Mt. Diablo Base and Meridian, in the Matheson Peak, California, U.S. Geological Survey 7.5-minute quadrangle(s).

Project Description: The Department of Fish and Wildlife (CDFW) is issuing an agreement to modify Class I, Class II, and Class III watercourses at existing road crossings, and divert water from Class II watercourses.

This is to advise that CDFW, acting as  the Lead Agency /  a Responsible Agency approved the above-described project and has made the following determinations:
