


**CENTRAL SAN JOAQUIN WATER CONSERVATION DISTRICT
NEGATIVE DECLARATION REGARDING ENVIRONMENTAL IMPACT**

1. **NOTICE IS HEREBY GIVEN** that the project described below has been reviewed pursuant the provisions of the California Environmental Quality Act of 1970 (Public Resources Code Section 21100 et seq.) and a determination has been made that it will not have a significant effect upon the environment.
2. **PROJECT NAME:** Central San Joaquin WCD – Barton Annexation 2
3. **DESCRIPTION OF THE PROJECT:** Annexation of Parcels 187-380-03 and 187-380-08, totaling 244.93 acres, adjacent to the existing South Easterly boundary of the District. The Project Description is more fully set forth in the Initial Study attached to and incorporated into this Negative Declaration by this reference. Based on the Initial Study, it has been found that the project will not have a significant effect on the environment.
4. **LOCATION OF PROJECT:** Areas contiguous to the South Easterly boundary of the existing District boundary, as shown on the map attached as Exhibit "A".
5. **NAME AND ADDRESS OF PROJECT PROPONENT:** Central San Joaquin Water Conservation District 11 S. San Joaquin Street, Suite 306, Stockton CA 95202.
6. **MITIGATION MEASURES:** None
7. A copy of the Initial Study and Checklist regarding the environmental effect of this project is on file at the offices of the Central San Joaquin Water Conservation District as set forth above. This study was:

 - Adopted with changes. Specific modifications supporting reasons are attached.
8. The Central San Joaquin Water Conservation District considered this Negative Declaration at a public meeting of its Board of Directors on June 5, 2025.
9. **DETERMINATION:** On the basis of the Initial Study of environmental impact, the information presented at hearings, comments received on the proposal and our own knowledge and independent research:
 - We find the proposed project **COULD NOT** have a significant effect on the environment, and a **NEGATIVE DECLARATION** is hereby adopted.
 - We find that while the project **COULD** have a significant effect on the environment, there will not be a significant effect in this case because the mitigation measures described on an attached sheet have been added to the project, and a **NEGATIVE DECLARATION** is hereby adopted.
 - We find the proposed project **MAY** have a significant effect on the environment and an **ENVIRONMENTAL IMPACT REPORT** is required.

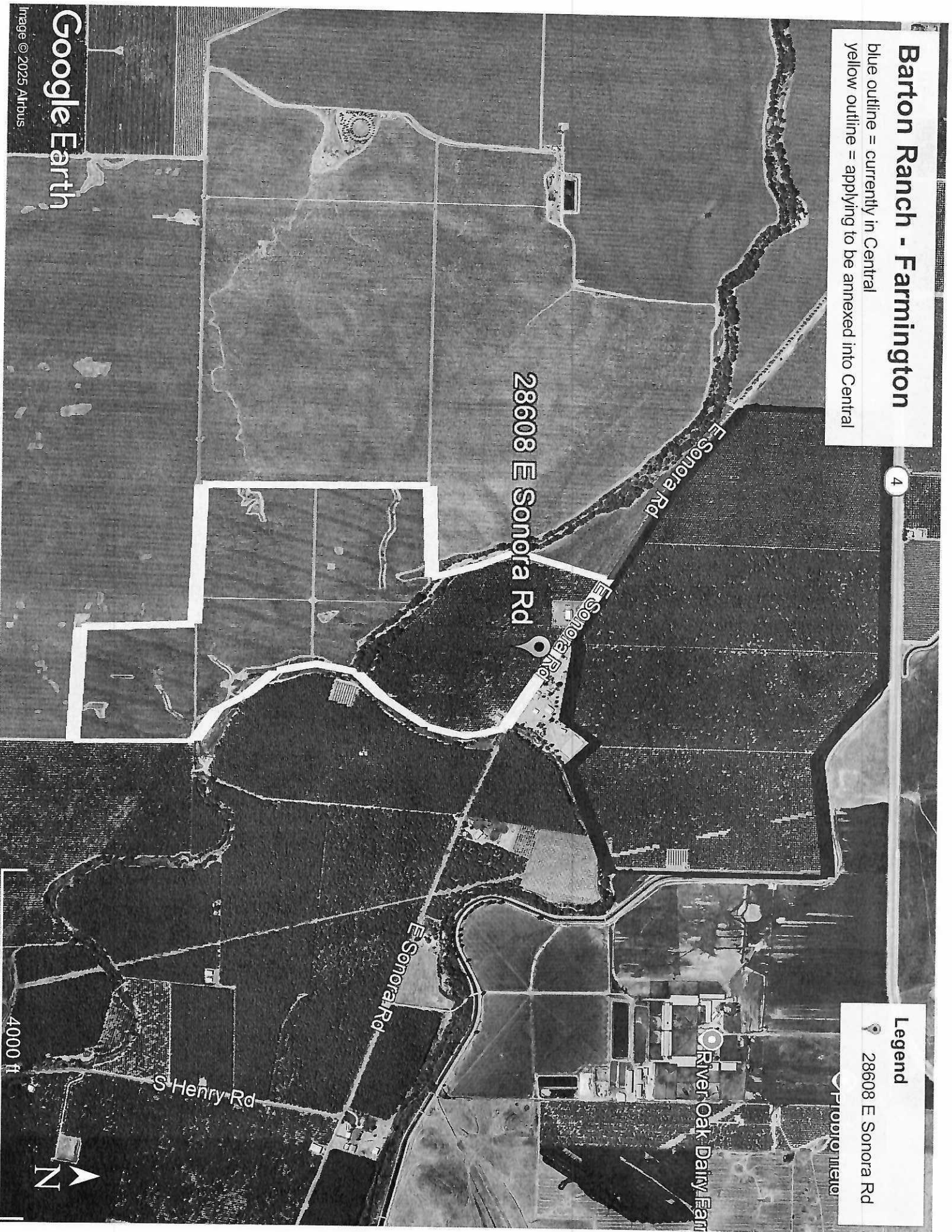

Discussion of Environmental Impacts and Evaluations:

Central San Joaquin Water Conservation District ("CSJWCD") is a District formed under the Water Conservation District Act of the State of California. It was formed to address issues of groundwater overdraft, stabilization of the aquifer, and recharge of the groundwater basin. The District consists of approximately 60,000 acres of fully developed agricultural land. CSJWCD supplies surface water to District landowners for the purpose of limiting the extraction from the groundwater basin and to aid in the recharge of the depleted aquifer.

CSJWCD has been importing surface water from New Melones reservoir since 1994. Approximately 40,000 acre feet is imported annually with service to approximately 20,000 acres. The efforts of CSJWCD have improved basin conditions by raising the groundwater table 13 feet since its establishment of the New Melones surface water project. This increase in the groundwater level benefits all areas within the District and those immediately adjacent thereto, specifically the two (2) areas for proposed annexation. Annexation of these two (2) areas will allow for additional surface water deliveries and control of groundwater extraction.

No environmental impact has been found because the proposed annexation will utilize existing water delivery infrastructure. The additional flow of water for the project is minimal and will not negatively impact the existing streambed and drainage facility. The proposed annexation will not require the construction of any new structures or facilities. Irrigation by surface water will replace existing irrigation by groundwater and will result in no change to existing land use and agricultural operation.

Sufficient water supplies are available to meet additional water delivery demands. However, District surface supplies are subject to dry year shortages. During such years if sufficient surface water is not available the project irrigation demand will be met by a return to groundwater pumping. This is not a significant impact as groundwater is the current irrigation method in the proposed areas.

Determination:

Based on the foregoing information in the initial study and environmental checklist it is determined that a Negative declaration should be adopted.
